  - o Nominations
    - President: Christina Fjeld, Justin Green, Heather Hamilton
    - Treasurer: Kat Merrill, April Mindt
    - Family Members:
      - Mark Pierson was nominated. Board did research on having multiple family members on the board. Research found that for a 5013c the IRS requires that public charities have at least 51% of the voting members of the board of directors be unrelated. Since Tiffany and Diane are on the board, the possibility of Mark being elected would put the current board over 51% and that is not allowed.

    - We will have a run off vote between the top two. If a tie still occurs after run off we will set another date for another runoff vote. this is according to Robert's Rules of Order
