1. The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality professional feed at regular intervals, and fresh water available at all times. The Buyer promises to provide a safe environment for the puppy/dog, and never allow the dog to roam freely without proper supervision. The Seller strongly recommends that the puppy/dog be micro-chipped in order to facilitate his return if lost or stolen, usually around 4 months old.

2. The Seller guarantees this puppy/dog to be of sound health and temperament at the time of this sale. A health record of all shots and worming will be provided by the Seller. The Buyer agrees to take this puppy/dog to a licensed veterinarian of their choice within 48 hours for a physical examination. Should puppy/dog be determined to be in ill health, the cause of which the Seller is clearly to blame, the puppy/dog may, upon a signed written diagnosis from said licensed veterinarian be returned to the Seller. Seller shall take said puppy to Seller's veterinarian for confirmation of buyer's veterinarian's findings. If diagnosis is able to be remedied by breeder's veterinarian or breeders choice of veterinarian at a cost less than or equal to the puppy, said breeder will have the choice to move forward with treatment or replace the puppy. If puppy is found to be in ill health, Seller shall take back the puppy. Seller will replace the puppy as soon as a new litter of similar size is available. The Seller assumes absolutely no responsibility for fees associated with caring for the puppy/dog. Seller guarantees no genetic defects for one full year. No other guarantees are given.



3. The Buyers agree not to use this puppy/dog for breeding and agree to have it spayed/neutered at the age recommended by their veterinarian (usually around 6 months of age). Receipt of procedure must be delivered to the Seller by email or mail. We have a strict spay/neuter policy. We carefully place puppies in loving homes as pets only. I understand that ALL legal/court fees from ANY breach (\$20,000 fine PLUS all income made from litters) of contract are purchaser's responsibility in BREEDERS Jurisdiction said Puppy will become Breeders property if contract is breached in any way. _____ Initials. I agree to spay/neuter my pet by age of vet recommendation (usually 5 ½ months for males and 6 – 7 months for females) and provide the receipt to Gunter Goldendoodles.

4. If at any time the Buyer can no longer retain possession of this puppy/dog, the Seller is to be notified and given first option of resuming full ownership of puppy/dog in order for the Seller to locate a new home. Refunds, if any, will be at the discretion of the Breeder/Seller. The dog will be returned with any registration if applicable and medical records. Should any circumstances arise that affect the quality of life of the puppy/dog, the breeder/seller is to be informed so that they may participate in determining the future of the puppy/dog. The Breeder/Seller reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this puppy/dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.
