Divisions, Classes and Rules for WALK THE TRAILS

DIVISIONS:

 $\mathbf{M} = \mathbf{M}\mathbf{E}\mathbf{N}$

F=WOMEN

PW = PEEWEE (5 YRS AND UNDER)

C = CUB (6 - 11 YRS)

 $\mathbf{Y} = \mathbf{YOUTH} (12 - 17 \mathbf{YRS})$

 $\mathbf{A} = \text{ADULT} (18 - 54 \text{ YRS})$

SR = SENIOR (55 & OLDER)

CLASSES:

FREESTYLE (FS): Bows with movable sights, stabilizers longer than 12", mechanical release aid.

FREESTYLE LIMITED (FSL): Bows with movable sights, stabilizers longer than 12", finger pads.

BOWHUNTER FREESTYLE (BHFS): Bows with sights w/fixed pins; mechanical release aide; stabilizers 12" or less.

BOWHUNTER FREESTYLE LIMITED (BHFSL): Bows with sights w/fixed pins; finger pads; stabilizers 12" or less.

BOWHUNTER (BH): Bows with no sights; finger pads; stabilizers 12" or less.

BAREBOW (BB): Bows with no sights; Stabilizers longer than 12"; finger pads.

TRADITIONAL (TRAD): Recurve bows (may use stabilizer), Longbows (wood arrows only).

YOUTH (Y): Any style.

CUB (C): Any Style.

PEEWEE (PW): Any Style.

RULES:

Scoring - 1 arrow per target. 12-, 10-, 8-point rings; 5 points anywhere else on the animal.

Scorecards <u>MUST</u> be turned in by 12:00 noon, Sunday, for awards eligibility. NO EXCEPTIONS!

Buck/Doe Spread – Does and a Buck, you are to shoot the Buck.

- If you shoot the doe, you will receive a score of -3 pts.
- If you have a doe tag, you will receive a 0 (zero) for that shot.
- If you don't have a doe tag, but have a Mulligan, you will be able to shoot again; your score will be the second score, -3 points.
- If you have a doe tag and a Mulligan, the score will be the second shot's score.

<u>Doe Tags</u> – Use when/if you hit a doe on a buck/doe spread. If you hit a doe on a buck/doe spread, you score a -3 for that target. When you use a doe tag, the -3 is then a 0 (zero).

You are allowed only 1 Doe Tag per Trail.

Mulligan – You shoot, and you don't like the score; use a Mulligan, re-shoot, and keep your second score.

You are allowed only 1 Mulligan per Trail.

<u>Hunt the Trails</u> – Follow and stay on the Trail. Shoot the target when you feel you have your best shot. You may ONLY WALK FORWARD, <u>NO</u> WALKING BACK FOR A BETTER SHOT THAT YOU MAY HAVE MISSED. Primitive/Traditional, Cub & Pee-wee shooters may walk closer to the target and shoot an ethical shot.

- **Binoculars ARE** allowed on the trails; **Range Finders** are **NOT ALLOWED**.
- Shooting the trails are allowed anytime during "safe light" legal shooting hours.
- NO ALCOHOLIC BEVERAGES ARE ALLOWED ON THE TRAILS.

WAIVER, RELEASE AND INDEMNITY AGREEMENT

This is a legal document that affects your legal rights and the legal rights of your heirs. If you do not understand it, you should consult your attorney before signing.

SINCE THE USE OF BOW & ARROW IS DANGEROUS, SOUTHWEST BOWHUNTERS AND ADAIR RANGES, INC. REQUIRES ALL SHOOTERS & OBSERVERS TO ASSUME ALL RISK BY SIGNING THIS AGREEMENT.

I, ______(please print name), hereby acknowledge that I have voluntarily applied to participate in and/or including the sport shooting activities conducted by the Southwest Bowhunters on the premises of Adair Ranges, Inc.

As lawful consideration of being permitted to enter upon the premises of or otherwise use the facilities of Adair Ranges, Inc. and/or participate in or observe activities of the Southwest Bowhunters, I, the undersigned, for my heirs, distributees, guardians, legal representatives, next of kin, assigns and all other persons, firms, associations or corporations who may be or will be liable to the Undersigned, whether directly or indirectly, from any and all present, past and future claims, demands or causes of action whatsoever:

- Hereby releases, waives, discharges and covenants not to sue, make a claim against, attach the property of, or otherwise prosecute Southwest Bowhunters and/or
 Adair Ranges, Inc., one of its affiliated organizations, its officers, directors, match officials, members, agents and/or employees, for all purposes herein referred to
 as Releasees, for liability on account of injury to the person or damage to the property or resulting in the death of the Undersigned whether caused from passive or
 active negligence of the Releasees or other-wise while the Undersigned is upon the premises of Adair Ranges, Inc. and/or participating in activities of the
 Southwest Bowhunters.
- 2. Hereby agree to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage or costs they may incur due to the present of any action of the Undersigned in or about Adair Ranges, Inc. and/or participating in activities of the Southwest Bowhunters and whether caused by the passive or active negligence of the Undersigned.

The Undersigned expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Arizona and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The Undersigned warrants the following statements are true and correct and understands that the Releasees have relied on them in entering the foregoing Release, Waiver, and Indemnity Agreement and in giving the Undersigned permission to participate in activities of the Southwest Bow Hunters or enter the Adair Ranges, Inc. premises.

- A. No oral representation, statements or inducements apart from the foregoing written agreement have been made.
- B. The Undersigned is fully aware of the risks and hazards inherent in entering upon said premises or in participating in or observation of any events held in or upon said premises and/or organization knowing the present condition may become more hazardous and dangerous during the time that the Undersigned is upon said premises.
- 3. THE UNDERSIGNED IS AWARE THAT SPORT SHOOTING WITH LOADED BOWS AND ARROWS EITHER INDIVIDUALLY, AS A MEMBER OF A GROUP OR AS AN OBSERVER IS A HAZARDOUS ACTIVITY AND DOES VOLUNTARILY PARTICIPATE IN THESE ACTIVITIES WITH KNOWLEDGE AND APPRECIATION OF THE DANGER INVOLVED WITH THE USE, HANDLING, OR FIRING OF BOWS AND ARROWS, FIREARMS, AMMUNITION, OR OTHER WEAPONS, USE OF ANY EQUIPMENT OR UTILIZATION OF ANY PROPS, AND HEREBY AGREES TO ACCEPT ANY AND ALL RISKS OF PROPERTY DAMAGE, INJURY OR DEATH.
- 4. The Undersigned gives consent to whatever medical care might be provided or available on the premises and further agrees to conform and comply with all the rules and regulations of Southwest Bowhunters and/or Adair Ranges, Inc.
- 5. THE UNDERSIGNED AGREES TO COMPENSATE OR REIMBURSE RELEASES FOR ANY COSTS, EXPENSES OR DAMAGES INCLUDING ATTORNEY FEES RESULTING FROM ANY CLAIMS BROUGHT AGAINST THEM FOR PROPERTY DAMAGE OR PERSONAL INJURY OR DEATH WHICH ARISE AS A RESULT OF MY PASSIVE OR ACTIVE NEGLIGENCE OR OTHER ACT WHILE PARTICIPATING IN THE ACTIVITIES OF SPORT SHOOTING OF THE SOUTHWEST BOWHUNTERS ("SWBH") AND/OR ADAIR RANGES, INC.
- 6. THE UNDERSIGNED HAS CAREFULLY READ, FULLY UNDERSTANDS ITS CONTENTS AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF ALL LIABILITY AND INDEMNITY AGREEMENT.

BAREBOW (BB): Bows with no sights; Stabilizers longer than 12"; finger pads.

TRADITIONAL (TRAD): Recurve bows (may use stabilizer), Longbows (wood arrows only).
