### Hi {COMPLIANT VENUE},

Thank you for taking my call and talking with me about everything. I greatly appreciate your perspective and input. Just for any future reference you might need, I am attaching an email/paper trail of all the correspondence from the state since 2017 up to the newly proposed legislation so it can be easily accessible in one place. I also wanted to note that if the legislation is passed, based on the documents we have access to, the fire marshal will be responsible for enforcing these fire and building code changes, not local authorities. Since the new proposed occupancy load will be calculated based on 7 square feet/person instead of 15 square feet, all of our maximum occupancy loads or max capacities will be changed. It seems as though the fire marshal will be given the ability to shift our Assembly group classification to align with the new code requirement. It is not 100% clear yet of the roles and scope. I can certainly keep you updated in the future if you want, or if you hear of anything new, we would greatly appreciate an update. Thanks again and have a great holiday season!

The 2017 Omnibus Jobs Bill included a provision (text pasted below) that adds places of public accommodation to the State Building Code. It includes special event center in the definition of a place of public accommodation, and requires the State Fire Marshal to review plans and inspect facilities. That bill became law.

"2017 Laws of Minnesota, Chapter 94, Article 2, Section 4. [326B.108] PLACES OF PUBLIC ACCOMMODATION SUBJECT TO CODE. Subdivision 1.

Definition.

For purposes of this section, "place of public accommodation" means a publicly or privately

owned facility that is designed for occupancy by 200 or more people and includes a sports or entertainment arena, stadium, theater, community or convention hall, special event center, indoor amusement facility or water park, or swimming pool.

Subd. 2.

Application.

Construction, additions, and alterations to a place of public accommodation must be designed and constructed to comply with the State Building Code.

Subd. 3.

Enforcement.

In a municipality that has not adopted the code by ordinance under section 326B.121, subdivision 2, the commissioner shall enforce this section in accordance with section 326B.107, subdivision 1.

Subd. 4.

Fire protection systems.

If fire protection systems regulated by chapter 299M are required in a place of public accommodation, then those plan reviews and inspections shall be conducted by the state fire marshal."

NEW BILL INTRODUCED IN 2018

It was heard in the House Public Safety Committee. A clone bill was heard in the House Jobs Committee. Neither of those bills became law and died when the Legislature adjourned in 2018.

Representative Howe was elected to the Senate in 2018 and introduced a bill, SF1839, earlier this year that is related to fire protection systems. This bill would give the State Fire Marshal authority to enforce the fire protection systems components of the Labor and Industry building codes and redirects the associated portion of the permit fee to the Fire Marshal's office.
