RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration for permitting Exhibitor to participate as an Exhibitor in the Main Street Fayette Craft Fair as directed by the relevant staff, the undersigned, for themselves, and for their respective heirs, personal representatives and assigns, agrees as follows:

Release and Waiver: The undersigned hereby RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE The City of Washington Court House or Main Street Fayette Members, (collectively, the “Releasees”), from and for any liability resulting from any personal injury, accident or illness (including death), and/or property loss, however caused, arising from, or in any way related to, Exhibitor’s participation in the Event, except for those caused by the willful misconduct, gross negligence or intentional torts of the above parties, as applicable.

Indemnification and Hold Harmless: The undersigned also hereby agrees to INDEMNIFY, DEFEND AND HOLD the Releasees HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities including, but not limited to, attorney’s fees, arising from, or in any way related to, Exhibitor’s participation in the Event, except for those arising out of the willful misconduct, gross negligence or intentional torts of the above parties, as applicable.

Property Damage and Insurance: The undersigned agrees that it shall be solely responsible for any loss or damage sustained to its property while the same is in transit to or from the Event, or while its property is at the Event. Exhibitor shall be responsible for obtaining appropriate insurance coverage.
