# What does the Code of Business Conduct say about Shared Business Entertainment and Gifts?

Recognizes that the giving and receiving of shared business entertainment and modest gifts is a customary way to strengthen business relationships

Prohibits employees from receiving or giving any gift or entertainment to anyone with whom Manulife has or is likely to have business dealings, if it could be perceived as an attempt to influence the recipient's judgment in carrying out their duties to Manulife or their employer

# Manager Notification versus Quarterly Reporting

All employees are required to keep their managers informed of any Shared Business Entertainment (given or received) unless the entertainment or gift is exempt.

All employess with access to the personal Trading Compliance Center ("PTCC") must record reportable entertainment and



#### **Manager Notification**

You can inform your manager directly

For expenses incurred by Manulife, your manager will be deemed to be notified of any gift or entertainment given if the expense was approved by your manager in Concur or other expense reimbursement system with appropriate description of the activity in the Concur system.

You and your manager may also agree that certain types of gifts and entertainment do not require specific manager notice each and every time. For example, you and your manager may agree that routine dinners with clients do not need to be reported to the manager each and every time, if they are otherwise recorded in PTCC



## **Key Elements - Entertainment**

#### What is Shared Business Entertainment?



An event paid for by Manulife or a Third Party and attended by both employees of Manulife and the Third Party

#### **Examples**

Tickets to a sporting event, greens fees, lunches, dinners, spa treatments, concert tickets, tickets to charitable events, etc. (when the donor is present)
