1. ANSWERS TO QUESTIONS

1.1 Question: Foodservice subcontractor: after reviewing this project and they need confirmation that the products are required for section 11 40 10 which is missing from the Technical Specs. There is a list of products only listed on drawing A-003 but are listed as Food Service Stock Equipment. Is this equipment that they currently have and will be used in the project or is this to be purchased as part of this tender? If we are to provide 11 40 10, please provide specifications.

Answer: The owner has no kitchen supplies and equipment, and the purchase of such supplies and equipment is a part of the tender. All the specifications are found on drawing A003 Specifications under the section 10 28 10 Washroom and other accessories 3. Canteen Accessories and Section 11 40 10 – Food Service Stock Equipment. **Please note that the Architectural Specifications are found on drawings A-001-A003.**

1.2 Question: Is it acceptable to go with 4mm/.060/4mm tempered laminated inside and out of the sealed units for this project? One of the suppliers is noting they are unable to go smaller than that. It would end up creating a smaller airspace on the sealed unit. Please clarify.

Answer: 4mm tempered glass is acceptable while maintaining a 1.5mm distance between layers of glass.

1.4 Question: Regarding aluminum doors, frames and windows (section 08 11 16, 08 50 50), can equal products from Anotec, Alumicor, or Kawneer also be acceptable?

Answer: Please refer to A-01 Item 1.1. Anotec Manufacturing Inc. Fixed and Projected Heavy Duty Insulated Window, Series 80 has been accepted as an equivalent product. Item 1.2 Anotec Manufacturing Exterior Aluminum Frames has been accepted as an equivalent product. Please refer to this Addendum, Item 2.2. to see the accepted equivalent products for aluminum doors and frames.

If, Alumicor or Kawneer products are to be considered as equivalencies, spec sheets for exact products and guarantees must be provided to be reviewed.

1.5 Question: Building section 2 A-401b references 2 A551 along gridline 3. This detail shows a structural steel member above the coiling door at equipment rental. This is not indicated on the structural drawings, please provide further details.

Answer: The structural members on line 3 are all detailed on the structural drawings S1B and S2B. The contractor shall use these structural drawings for these wood members that consist of a continuous 228 mm x 406 mm at roof beam, a 44 x 406 lintel type L6 above the coiling door at canteen and a 38 x 140 mm wood bearing wall type WL1 between these two beams c/w specific gang studs type G1 aligned with the 137 x 406 roof beams.
