STAGE / DJ REQUIREMENTS

- 1 WIRELESS MIC
- 2 - 4 LINKED PIONEER CDJ 3000/ 2000, 1000 MK2 / MK13 CD PLAYERS (NO TURNTABLES OF ANY KIND - TALENT IS A CDJ ONLY DJ!!!!!!)
- 1 MULTI-INPUT DJ MIXER (PREFERABLY BY PIONEER: DJM-900NXS2)
- 1 BOOM MIC STAND FOR DJ (DESKTOP MODEL PREFERRED)
- 1-2 HIGH QUALITY SPEAKER MONITORS (PREFERRED BRAND, JBL)
- IF ONLY ONE MONITOR IS PROVIDED MUST BE SET UP ON LEFT SIDE.
- 1/2 HOUR SOUND CHECK AT EACH VENUE AT LEAST 4HRS PRIOR TO SCHEDULED PERFORMANCE (IF POSSIBLE).
- ARTIST AREA MUST NOT BE ACCESSIBLE BY THE GENERAL PUBLIC FROM THE FRONT, SIDES, AND MOST IMPORTANTLY, THE BACK.
- DURING ARTIST PERFORMANCE, THERE ARE TO BE NO UNAUTHORIZED INDIVIDUALS IN THE DJ BOOTH/AREA UNDER ANY CIRCUMSTANCES UNLESS CLEARED BY TALENT REPRESENTATIVE OR MANAGEMENT.
- (4) FOUR BOTTLES OF WATER
- (1) ONE SECURITY GUARD IN SIGHT AT ALL TIMES

TRANSPORTATION

TRAVEL ARRANGEMENTS & DOCUMENTS MUST BE PROVIDED TO ARTIST MANAGEMENT 2 WEEKS PRIOR TO DEPARTURE DATE.

FLIGHTS:

PROMOTER IS RESPONSIBLE FOR PURCHASING (1) COACH/ECONOMY ROUNTRIP FLIGHT OUT OF HARTSFIELD - JACKSON AIRPORT.

MUST BE WINDOW SEAT AND EXIT AISLE (IF POSSIBLE) .

- (1) SUV OR LUXE VAN FOR TALENT TRAVEL TO AND FROM AIRPORT, HOTEL, AND PERFORMANCE VENUES.

ALL PASSENGER VEHICLES MUST BE APPROPRIATE FOR ARTIST TRANSPORT AND HAVE LICENSED, PROFESSIONAL DRIVERS.

SECURITY

SECURITY SHALL BE PROVIDED BY THE PROMOTER UNLESS OTHERWISE STIPULATED.

ALL SECURITY PROVIDED MUST BE BONDED AND LICENSED TO BE ARMED PROTECTION PROFESSIONALS. NAMES AND CREDENTIALS MUST BE PRESENTED TO ARTIST MANAGEMENT PRIOR TO TRAVEL ABROAD (IF APPLICABLE).

LODGING

ALL HOTEL ACCOMMODATIONS MUST BE OF 3-4 STAR STATURE OR ABOVE AND IN A SECURE, REPUTABLE SECTION OF TOWN (IF APPLICABLE).

ALL HOTEL ARRANGEMENTS MUST BE PROVIDED TO ARTIST MANAGEMENT AT LEAST 2 WEEKS PRIOR TO DEPARTURE DATE. INFORMATION NEEDED: NAME OF HOTEL, ROOM NUMBER (S), CONTACT AT HOTEL, ETC.

ADDITIONAL REQUIREMENTS

ALL BALANCES DUE MUST BE PAID IN CERTIFIED FUNDS TO ARTIST PRIOR TO DEPARTURE FROM HOST CITY TO PERFORM. NO EXCEPTIONS.

PERFORMANCE FEES MAY BE SUBMITTED THROUGH BANK DRAFT OR PAYPAL IS REQUESTED BY BOOKING ENTITY IF REQUESTED. DETAILS FORWARDED UPON REQUEST.
