Mission Statement and Rental Criteria

Thank you for your interest in one of our properties! All properties are offered without regard to race, color, religion, national origin, sex, disability, or family status.

We are committed to providing our tenants and our community with quality homes and exceptional service. We take great pride in offering clean, quality homes, at competitive prices. We strive to return all phone calls or texts within 24 hours (usually within the hour), and complete all maintenance issues and repairs quickly and efficiently. We want you and your family to be proud of your home and we will always strive to improve the aesthetic look of any property that we own.

Please find below our rental criteria requirements to qualify to rent a home:

- · Must be willing to sign a minimum 12 month lease. Preference given to candidates who wish to sign an extended month lease of 24+ months.
- Total gross monthly income must be a minimum of 3X the monthly rent. (Overtime and child support may be considered if documentation can be provided showing regular consistency for the past 12 months.) 2.5X the monthly rent may be considered with higher credit score and all other information is satisfactory.
- · No evictions in the past 10 years.
- · No felony convictions in the past 10 years. No sex offenses or crimes against other persons. Other convictions are evaluated based on the charge and length of time since the charge.
- · No unpaid balances with prior landlords and no active collection accounts or tax liens.
- · Must have a minimum credit score of 600. If credit score is below 600 and applicant qualifies in all other areas, application may be approved with increased security deposit and/or co-signer at Landlord's sole discretion.
- · Must be be able to furnish acceptable proof of the required income. 12+ months employment with current employer preferred. (Self-employed applicants must provide most recent tax returns for income verification.)
- · Must be able to provide a minimum of 12 months valid, verifiable, and positive rental history with no derogatory remarks. Valid rental history is a written lease or month-to-month agreement.
- · Must have good housekeeping, payment, and maintenance references from all previous Landlords.
- · A satisfactory background check is required of all applicants, including eviction and criminal records searches.
- · A valid driver's license or government issued photo ID is required of all applicants.
- · All occupants (adults and children) must be listed on the application. Individuals residing in the home for more than 14 days must have Landlord's prior written approval.
- · Total occupancy is limited to 2 people per bedroom.
- · A maximum of 2 pets are allowed. No cats. Additional pet fees are required.
