4. First-Aid Measures

Description of first aid measures

General advice:

5. Fire-Fighting Measures

Extinguishing media

Suitable extinguishing media: foam, dry powder, carbon dioxide, water spray

Special hazards arising from the substance or mixture

Hazards during fire-fighting: carbon monoxide, carbon dioxide, The substances/groups of substances mentioned can be released in case of fire.

Advice for fire-fighters

6. Accidental release measures

Further accidental release measures:

7. Handling and Storage

Precautions for safe handling
