No one can Guarantee Genetics. The Breeder guarantees that if your Doberman should die under the age of (2) yrs. old from a genetically caused health issue; the Breeder will give the buyer a replacement puppy of equal value from the next available litter of 4 or more pups. In NO instance will Breeder provide a refund in lieu of a replacement puppy.

Proof of sudden death due to a genetic illness must be provided to the Breeder for my Veterinarians review and concurrence that the death was due to a genetic cause, in order for a replacement puppy to be provided Breeder will be available for the life of this Doberman to answer any questions and provide help.

Furthermore: Breeder will not provide a refund or exchange for any Doberman which was injured or became sick after leaving the Breeders premises. Buyers are advised to; limit the exposure of their new puppy to non-household dogs and outside high traffic areas until the puppy is at least (12) weeks old

and has received its (2nd) puppy vaccination. It is in the pup's best interest health wise to not expose the pup to very many outside dogs and high traffic areas until the last vaccine is given.

Furthermore: The Buyer agrees to maintain preventative health care of the Doberman including and not limited to; recommended inoculations, treatments for internal & external parasites.

Furthermore: The puppy should be fed a premium dog food. Breeder recommends holistic or all-natural dog food to encourage optimum health and longevity. Be careful to check all dog treat ingredients as well for corn as a first ingredient and other harmful ingredients and cancer-causing dyes.

Furthermore: By signing the contract buyer acknowledges that behavior and temperament is based on a combination of genetics and experiences the Doberman gains not only with the Breeder but with its new family its new environment. Improper socialization and lack of consistent Obedience Training will adversely affect the good genetic temperament the Doberman was born with. To ensure that the Doberman receives proper socialization and training to strangers, places and other dogs; all Buyers

should enroll in and graduate from a minimum of 2 consecutive obedience courses by the time the Doberman is (1) yr of age.

Furthermore: The Breeder would like to encourage the Buyers to earn performance titles and will pay a \$100.00 rebate for a copy of each AKC or UKC title certification in a Rally, Obedience, Agility or SAR provided by the Buyer in the aforementioned areas.

A \$50.00 rebate for obtaining a BH, DPCA, Working Aptitude Certification (WAC) or a \$25.00 rebate for an AKC or CGC certificate. These are not required for purchase, but it's a strong recommendation for validation of Doberman type, temperament and proper training.

Buyer: Agrees to remain in contact with the Breeder and to call should they any questions. Or need advice about their Doberman or are unsure of how to handle a particular issue or behavior.
