ESTIMATES

- Estimates provided through photos, email, or messages are not final and may change after an in-person inspection.

AUTHORIZATION TO REPAIR

- By authorizing repairs, you grant Wesley's Paint & Body Shop permission to:
- Perform necessary repairs
- Order parts
- Test drive the vehicle as needed
- Authorization may be given in person, by phone, or electronically.

PARTS

- Replacement parts may include OEM, aftermarket, recycled, or reconditioned parts, depending on availability and insurance guidelines.
- Parts availability and shipping delays may affect repair timelines.

REPAIR TIMELINES

- Due to unforeseen circumstances beyond our control, including parts availability, insurance approvals, weather delays, or additional damage discovered during repairs, repair completion dates are estimates only and cannot be guaranteed.

PERSONAL PROPERTY

- Customers are responsible for removing all personal items from their vehicle prior to repairs.
- Wesley's Paint & Body Shop is not responsible for any items left in the vehicle at the time of repairs, including but not limited to personal belongings, electronics, cash, documents, or aftermarket accessories.
