### **Landscape**

February in North County San Diego is basically the month where your garden flirts back. Days are cool, nights are mild, and the soil is just warm enough to start planting cool-season crops like lettuce, peas, carrots, broccoli, and beets—while citrus trees are strutting around heavy with fruit like they know they're irresistible. It's also prime time to prune roses and deciduous fruit trees, which feels oddly on-theme since Valentine's Day traces back to ancient Romans giving roses as symbols of love (clearly gardeners were involved). Fun fact: Valentine's Day is the second-largest floral holiday after Mother's Day, and roses make up nearly 60% of those bouquets—so when you're pruning yours this month, think of it as tough love for future romance. Add compost, check irrigation after winter rains, and keep an eye out for sneaky aphids, because even in February, love—and pests—are in the air.

That said, we've had a lot of "anonymous" complaints regarding trash cans. I started to address the offenses but it's well over 1/2 of Costa Serena. I can only reiterate the CCR guidelines as well as WM's recommendations of not putting your cans out until the evening before or morning of and taking them back in same day. 🌸之心

Anyone failing to obtain a permit before starting work will be in violation of the CC&R's." If you have any questions, please call a permit committee member.**

### RECYCLE REPORT

We're off to a great start - in January we added \$197.82 to our account. There were only 2 months last year when we made more in a month! BTW \$167.91 was our monthly average.

Mark and I want to thank you for separating clean, dry plastic, glass and aluminum, and for removing caps to make it easier (and faster) for us. The recycling company pays less for wet containers so we empty them. Don't forget to put those caps in the bag tho. Remember that we can **NOT** get paid for plastic and/or glass bottles and/or aluminum cans, that had **any kind of food or oil** in them (or mold).

Also thank you for not bringing **SCRAP**: no solid white and/or solid colored plastic bottles for example yogurt drinks, Ensure, bleach, etc or ANY cleaning product container. No plastic juice and/or large opaque milk & water bottles, UNLESS they have CRV on them. **Please put these in your city blue recycling bin**, since it takes a **huge bag** to make a quarter!

**YES** to rinsed containers such as aluminum beverage cans; plastic ice tea; glass soda, beer, wine bottles and anything else marked CRV or California Redemption Value.

Just drop off your bags over the west gate at 3639 North Way or call/text Lynette 760-717-9121 if you need a pick up and/or have questions. Don't forget to take some empty bags when you drop off. Many just had water bottles in them. There's probably enough for your neighbors too.

# MINUTES OF COSTA SERENA GENERAL MEETING

Held at Sharon Martinson's patio, 3280 Pearl Lane; Saturday, January 10, 2026

Board members in attendance: Dick Bartolucci, Jim Draves, Steve Good, Sharon Martinson, Lesleigh Maggio and Barbara Hillary.

Sharon led the Pledge of Allegiance. The minutes from the previous meeting were approved by Barbara, with second by Lesleigh.

Thirteen members from the community attended and introduced themselves.

Committee reports were given.

Barbara reported there are no open age compliance cases, and none have been closed in the last three months. Currently three houses are for sale and five are available for rent. Over the last three months, there have been 10 sales and 11 houses rented out.

Lesleigh has nine open landscape complaints, most involving trash bins. Trash bins are to be put out no earlier than 4:00 am on the Tuesday before the Wednesday pickup; otherwise they are to be put out of sight. One new complaint concerns a fence on Mira Pacific.

Permits. Jim said it was slow due to the holidays; a couple of windows have been replaced.

Dick reported a bank balance of \$30,973.39. Donations in 2025 were \$15,815. Donations in 2024 were \$18,265. Donations can be made electronically w Zelle; see elsewhere in newsletter for details.

During the open meeting, one resident asked about the status of the multi-unit condominium complex which fronts Rancho Del Oro on the west side of Costa Serena. Details are lacking, but it appears developers have run out of money, stalling construction, now about six years running.

The meeting was adjourned on motion by Dick and second by Lesleigh.

Following the community meeting, we heard from Martin Carr, a representative of Roof Maxx in Carlsbad. Roof Maxx uses a plant-based product which is sprayed over existing roofing material and extends a roof's life by five years. The cost for half a duplex in Costa Serena is about \$2,500. A typical roof replacement where asphalt shingles are removed and replaced with new should cost \$9-12,000 for half a duplex. Martin said if a Costa Serena resident gets a bid for more than \$12,000 to replace a roof, they are paying too much. If one has solar panels, the average cost to remove and replace existing solar panels is \$100-200 per panel, when done in conjunction with roof work. Roof Maxx is licensed, bonded and insured and has completed a few roofs in Costa Serena, Martin said.
