Vendor Agreement

1. Agreement Term:

This Agreement shall be effective as of the date mentioned above and shall remain in effect until terminated by either party with prior written notice.

2. Vendor Responsibilities:

- Compliance: Vendor agrees to comply with all applicable laws, regulations, and permits related to their products/services.
- Insurance: Vendor shall maintain appropriate insurance coverage for their operations and provide proof of insurance upon request.
- Product/Service Quality: Vendor shall ensure that their products/services meet high-quality standards and are suitable for the intended purpose.
- Licenses: Vendor shall obtain and maintain any necessary licenses or certifications required for their business operations.
- Health and Safety: Vendor shall adhere to health and safety guidelines, maintaining a clean and safe environment for customers.
