March 6, 2007

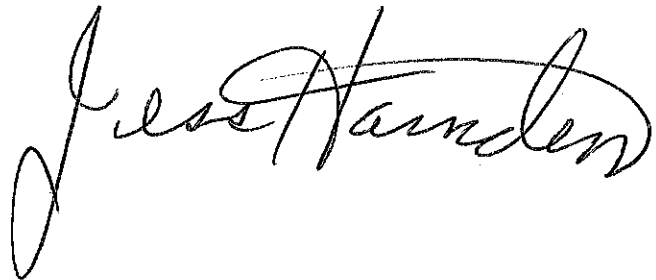
