- 1) **MEETING CALLED TO ORDER** – Mayor Alan Griffin calls the meeting to order at 622: p.m.

- 3) **PLEDGE OF ALLEGIANCE**
- 4) **MOTION TO ACCEPT THE JUNE AGENDA** – Devin Keeling makes a motion to amend the agenda to remove 5) from agenda due to errors. Dalyn Waite 2nd the motion with council in agreement.

- 5) **APPROVAL OF COUNCIL MINUTES FROM REGULAR MEETING ON MAY 12, 2026, SPECIAL AND CLOSED MEETINGS ON JUNE 1, 2026** – Removed from Agenda due to minute errors to be corrected and brought to the next meeting.

- 7) **VISITORS** –
 - a) **CINDY MYERS** – request to move trophies from the old Community Center.
- 8) **NEW BUSINESS** –
 - a) **TROPHIES AT COMMUNITY CENTER** – Devin Keeling makes a motion to remove the trophies and store until a sufficient place to display is decided. Warren Myers 2nd the motion with council in agreement.

 - b) **MAYORAL NOMINATIONS** – Mayor Griffin stated that due to Larry Wald being a large volume user of our sewer system, he would have to abstain from voting during some instances and Carterville needs to be able to have full voting power. City administrator, Jon Cook had a conversation with Larry who verbally resigned during the conversation. However, he has not submitted anything in writing. Due to the potential conflict of interest, the mayor requested Larry Wald be removed from the 201 Board.
Devin Keeling makes a motion to remove Larry Wald from the 201 board. Brenda Cupp 2nd the motion with council in agreement.

Mayor Griffin nominated Cody Franks to replace Larry Wald for the 201 board.
Devin Keeling makes a motion for Cody Franks to be on the 201 Board. Judy Martin 2nd the motion with council in agreement.
Motion passed.
 - c) **PARKING ON EAST POPLAR** – Devin Keeling makes a motion to create an ordinance to have no street parking on East Poplar. Judy Martin 2nd the motion with council in agreement.
Motion passed.
General consensus was that notification attempts be made to residents on that street.
 - d) **PURCHASE OF COMPACT TRACT LOADER (SKID STEER)** – Tabled until more information is available on what funds will be used as a down payment. A special meeting will possibly be held once this information is available.
 - e) **DISCUSSION OF TOWN HALL MEETINGS** – General consensus was that the City Admin and/or City Clerk email for dates of availability and times. Council would like to have quarterly town halls with 3-5 subjects each session depending on what the interest of citizens is at that time.
 - f) **DISCUSSION ABOUT PARKS COMMITTEE AS ADVISORY GROUP PER CITY ATTORNEY** — General consensus was to have City Attorney, Derek Snyder draft an ordinance to revise the current ordinance to fit the current committee.
