Coming South on I-75: Take exit 50A for Dryden Rd. Keep left at the fork, follow signs for Dryden Rd N. Turn left onto Dryden Rd. Then turn left onto Arbor Blvd. Take Arbor Blvd till it ends into River Rd. Turn left on River Rd., proceed approximately seven-tenths of a mile. Dayton Dog Training building is the last building on the left just past the Orbit Industrial Park and just before the lake on the left side.

Detour coming South on I-75: Exit at Edwin C Moses Blvd. Turn right – go past Love's Truck Stop to 2nd traffic light. Turn left onto Dryden Rd. follow till the next traffic light and turn right onto River Rd. follow River Rd about 1.5 miles to just past Orbit Industrial Park on the left – you will see the Dayton Dog Training sign on the left.

Coming North on I-75: Take the Dryden Rd exit – turn left onto Dryden Rd – follow to Arbor Blvd. turn left onto Arbor Blvd – follow to end at River Rd turn left – Dayton Dog Training building is on left about seven-tenths of a mile, just past the Orbit Industrial Park on left.

Detour coming North on I-75: Take exit 47 at West Carrollton. Turn right off the ramp. Go to the first traffic light and turn left onto Dryden Rd. Go straight thru the first light you come to - watch for the third left tun lane, just past the end of the Heidelberg Distribution Center. Turn left onto E. River Rd. you will pass back over I-75, follow around the curve past the lake on the right-hand side, the first building is Dayton Dog Training Club.
