Schedule

GENERAL RULES

(These rules apply to the entire show.)

1. This Flower Show conforms to the standards established by National Garden Clubs, Inc. (NGC). The HANDBOOK FOR FLOWER SHOWS (HB), 2017 EDITION, with any revisions found on the National Garden Clubs website under Flower Show School Resources, Handbook Update Pages and is the authority for all issues not covered by the schedule which is THE LAW OF THE SHOW.
2. Entries are open to all members of the Tulsa Garden Club, members of the affiliate clubs of the Tulsa Garden Center, or guest members of Oklahoma Garden Clubs, Inc. and the public, provided they are approved by the Class Chair.
3. Entry tags/cards are available from the Entries Chairs and at regular Club meetings. Entry cards are to be filled out in advance.
4. This schedule and the Exhibitor's Sheets for Horticulture are available online at: www.tulsagardenclub.org and at each Tulsa Garden Club meeting.
5. Online registration is coming soon! Check the Tulsa Garden Website www.tulsagardenclub.org for more updated information.
6. Each exhibitor must fill out an Exhibitor's Sheet, available online at www.tulsagardenclub.org before specimens may be placed.
7. Complete procedure for making entries in the Divisions varies and can be found in the Division Rules for each Division.
8. All entries will be accepted beginning Tuesday, October 17, 2023, from noon-7 p.m., and Wednesday, October 18, 2023, from 7-9 a.m., at the Tulsa Garden Center.

9. Entries are to be removed between 4 and 7 p.m., Wednesday, October 18, 2023.
10. Judging will begin at 10 a.m., Wednesday, October 18, 2023. Judging will be by the NGC Standard System of Awarding, as per the (HB17).
11. The Classification Co-Chairs for each Division checks exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility.
12. The General Show Chair and the Classification Co-Chairs for each Division are available during judging for possible consultation. They, along with the Judges and Clerks, are the only personnel allowed on the floor during judging.
13. The decisions of the judges are final. Awards may be withheld if not merited.
14. There must be an emphasis on FRESH plant materials; no artificial plant material is permitted in any exhibit in any division.
15. Each exhibitor is limited to one (1) entry per class, except in the Horticulture Division.
16. Table and exhibit space dimensions are expressed by depth by width by height.
17. All tables will be covered with black tablecloths.
18. The Tulsa Garden Club will strive to assure the safety of all items after arrival and placement but is not responsible for any loss or damage to exhibits.
19. No plants on the state endangered species list or on the state noxious plant list will be allowed. Native wildflowers obtained legally may be entered. For information: <https://plants.usda.gov/home/raritySearch> <https://plants.usda.gov/home/noxiousInvasiveSearch>

AWARDS

The NGC Standard System of Awarding (HB17, Ch. 1 – pg. 5) is used in all Divisions.

Only one (1) First Place - Blue Ribbon = 90+ Points

Only one (1) Second Place - Red Ribbon = 85+ Points

Only one (1) Third Place - Yellow Ribbon = 80+ Points

One (1) or more Fourth Place - White Ribbon = 75+ Points

All blue ribbon-winning exhibits and all non-blue ribbon exhibits scoring 90+ points must be signed and dated by an NGC Accredited Judge on the judging panel.

HORTICULTURE DIVISION I TOP EXHIBITOR AWARDS

Division Award – Award of Horticultural Excellence

Each division must include at least two (2) or more sections, except for Education Division. Only one (1) award will be offered to the highest scoring blue ribbon exhibit scoring 95 or more and correctly named exhibit in the entire Horticulture Division. It is a rosette of green, orange and blue ribbons. (HB17, Ch.5, p. 40)

Section Awards – Unlimited number can be offered scoring 95+ (only one (1) award per section). Each section must consist of three (3) or more classes.

Arboreal Award – For cut or container-grown trees and/or shrubs. It is a rosette of green ribbons.

Award of Merit – For all cut non-woody specimens including vines. It is a rosette of orange ribbons.

Collector's Showcase Award – For collections and displays. It is a rosette of brown and green ribbons.

Elfin Award – For petite horticulture specimens in a non-Petite Standard Flower Show. It is a small rosette of chartreuse and purple ribbons.

Grower's Choice Award – For all container-grown plants. It is a rosette of dark green ribbons.

EDUCATION DIVISION II TOP EXHIBITOR AWARD

Division Award – Educational Top Exhibitor Award

A minimum of two (2) educational exhibits designated as eligible must be present. The exhibit may be the work of an individual. Only one (1) award will be offered per show. It is a rosette of brown and white ribbons. (HB17, Ch.5, p.43)

BOTANICAL ARTS DIVISION III TOP EXHIBITOR AWARDS

Section Awards – each section must consist of at least three (3) classes with at least twelve (12) exhibits required in all classes combined.

Botanical Arts Horticulture Award – It is a rosette of light brown ribbons.

YOUTH DIVISION IV TOP EXHIBITOR AWARDS

One (1) award per each of the three (3) age groups; three (3) awards may be offered. It is a rosette of red/white/blue ribbons.

RECOGNITION AWARDS

Sweepstakes Award – One (1) each for Horticulture and Botanical Arts and Overall, Flower Show. It is a rosette of green/white ribbons. Awarded to the one (1) exhibitor scoring the most points for exhibiting in each of the following divisions: Horticulture Division, Botanical Arts Division, and Overall, Flower Show.

SPECIAL TULSA GARDEN CLUB MEMBER AWARDS

Helen Pearce Memorial Award – Awarded for the highest scoring Foliage Container Grown exhibit in the Horticulture Division, Classes 13, 14, 15, 16, and 20. It is a rosette of two (2) shades of pink ribbons.

Loyce Anderson Memorial Award -- Awarded for the highest scoring Cacti or Succulent exhibit in the Horticulture Division. It is a rosette of black and red ribbons.

Mary Byrd Memorial Award – Awarded for the highest scoring Arboreal Exhibit by a novice* exhibitor in the Horticulture Division, Classes 21, 22, and 23. It is a rosette of green and gold ribbons.

Tulsa Garden Club Special Award – Awarded for the highest scoring Combination Planting exhibit in the Horticulture Division. It is a rosette of yellow ribbons.

**Definition of a novice designer/exhibitor is a Tulsa Garden Club member who has not won a blue ribbon in the named division in a Tulsa Garden Club Flower Show.*

DIVISION I HORTICULTURE RULES

(These rules apply to the Horticulture Division only.)

1. **The NGC exhibit policies are printed in (HB17, Ch.6, p.55).**
2. All exhibits must be FRESH. Dried and preserved specimens may be entered in the Botanical Arts-Horticulture Division.
3. All exhibits must have been grown by the exhibitor.
4. Plant material must be in its natural state and may not be altered by application (treatment) of oil, commercial “shine” products, etc., that change the natural appearance. No wiring of specimens is permitted.
5. Only foliage and/or flowers naturally grown and still attached to the specimen are permitted in the Flower Show. Unattached foliage is never included with a cut bloom specimen.
6. All plant material must have been in the possession of the exhibitor the appropriate number of days listed in chart (HB17, Ch. 6, p.55). Annuals 90 days, *July 18, 2023*, (EXCEPTION: no minimum for early maturing seeds and/or transplants); Bulbs 90 days, *July 18, 2023*, (EXCEPTION: no minimum for forced bulbs/corms/ tubers/rhizomes, such as: amaryllis, paper whites); Houseplants 90 days, *July 18, 2023*, Perennials 90 days, *July 18, 2023*, Combination Plantings grown together for 6 weeks, *August 18, 2023*, except troughs 6 months, *April 18, 2023*, Arboreal 6 months, *April 18, 2023*.
7. The rules for a single species, cut or container-grown specimens are listed in THE HANDBOOK FOR FLOWER SHOWS or its supplement, HORTICULTURE EXHIBITING AND JUDGING.
8. To receive an NGC Top Exhibitor Award, the Exhibitor must identify his/her entry by its binomial or currently accepted scientific designation. (Consult the HANDBOOK FOR FLOWER SHOWS, EXHIBITING IN THE HORTICULTURE DIVISION, CHAPTER 6.)

SECTIONS AND CLASSES

Eligible for *Award of Horticulture Excellence*

SECTION A Flowering Cut Specimens

“A MOSAIC OF CUT FLOWERS”

Eligible for *Award of Merit*

Exhibits will have one (1) stem with one (1) bloom.

Class 1 - Chrysanthemum

Class 2 - *Rosa*

Class 3 - *Zinnia*

Class 4 - Any other worthy specimen

SECTION B Non-Flowering Cut Specimens

“GREEN COUNTRY”

Eligible for *Award of Merit*

Exhibits will have one (1) stem.

Class 5 - Coleus

Class 6 - Philodendron

Class 7 - *Hosta*

Class 8 - Any other worthy specimen

SECTION C Container-Grown Flowering

“INDOOR SYMPHONY”

Eligible for *Grower’s Choice Award*

Exhibits will be a flowering species grown in a container. Must have grown exhibit for 90 days. Containers not to exceed 10 inches.

Class 9 - Begonia

Class 10 - Orchidaceae

Class 11 - *Streptocarpus*

Class 12 - Any other worthy specimen

SECTION D Container-Grown Non-Flowering

“THE GREEN INTERMISSION”

Eligible for *Grower’s Choice Award*

Exhibits will be one (1) species grown in a container. Must have grown exhibit for 90 days. Containers not to exceed 10 inches in diameter.

Class 13 - *Aspidistra*

Class 14 - Cacti

Class 15 - Succulent

Class 16 - Any other worthy specimen

SECTION E Petite Horticulture Specimens

“THE ARMS OF CHERUBS”

Eligible for *Elfin Award*

Exhibits are naturally small growth, or those designated as dwarf or miniature varieties or cultivars by nurseries and plant societies.

Class 17 - Arboreal – One (1) branch, must include an apical tip, central leader and several nodes, not to exceed 18” in length—must be grown by the exhibitor for 6 months.

Class 18 - Flowering container grown specimen – in pot not to exceed 4 inches - Must have grown exhibit for 90 days.

Class 19 - Flowering cut specimen – three (3) stems in a container.

Class 20 - Foliage container grown specimen – in pot not to exceed four (4) inches – Must have grown exhibit for 90 days. Eligible for the *Helen Pearce Memorial Award*.

SECTION F Arboreal

“THE MANY DIRECTIONS OF GROWTH”

Eligible for *Arboreal Award*

Exhibits are cut or container-grown trees and/or shrubs and must be grown by the exhibitor for six (6) months. Novices are eligible for the *Mary Byrd Memorial Award*.

Class 21 - Coniferous foliage branch from a shrub or tree – one (1) branch, must include an apical tip, central leader and several nodes, not to exceed 30” in length.

Class 22 - Berried branch from a shrub or tree – one (1) branch, must include an apical tip, central leader and several nodes, not to exceed 30” in length.

Class 23 - Non-conifer evergreen shrub or tree – one (1) branch, must include an apical tip, central leader and several nodes, not to exceed 30” in length.

SECTION G Combination Plantings

“THE RISE OF LIVING ART”

Eligible for *Grower’s Choice Award*

A grouping of three (3) or more botanically different plants with similar cultural requirements such as light, water and humidity. Natural accessories are permitted in all combination plantings but must be in scale with plantings and container, and theme appropriate to the plants. Containers not to exceed (twelve) 12 inches.

Class 24 - Hanging Gardens – group of indoor/outdoor plants in a single container or multiple containers with the appearance of a single container, suspended or growing vertically such as living wreaths, vertical gardens, Kokedama, hanging baskets.

Class 25 - Planters – a grouping of plants in an indoor or outdoor container.

Class 26 - Terrariums -a miniature landscape in a container with high transparent sides. The top may be closed or open.

SECTION H Collections

“TROUPE OF BEAUTY”

Eligible for *Collector’s Showcase Award*

1. A minimum of five (5) different specimens (cut and/or container grown) exhibited in individual containers, or the appearance of being individually exhibited.
2. Specimens such as evergreens and some epiphytes not requiring containers must appear as individual specimens. Some sort of individual plate, mat, etc., is required and is to be provided by the exhibitor.
3. Specimens must be related, such as all one (1) plant family (Rosaceae, Pinaceae), one (1) genus (*Hosta*), similar characteristics, (Bromeliad, Orchid, Fern in containers, shade foliage, flowering annuals, vegetables), etc. The exhibitor must provide a card stating the plant relationships.
4. Advance registration required by *October 10, 2023* to ensure space is available.
5. The collection constitutes a single entry and only one (1) entry card is used.
6. Placement of specimens within the exhibit is the responsibility of the exhibitor.

7. Staging containers must be compatible and furnished by the exhibitor. Staging accessories such as mats, risers, etc., are permitted but must not detract from the specimen; plant material must dominate.
8. Each specimen must be correctly and clearly labeled with the current scientific designation, and in a manner to easily identify the specimen's location in the collection. This may be done with a single chart or individual placards.
9. Individual specimen scores in the Collection are NOT averaged; the lowest scoring specimen in the Collection will determine the highest ribbon possible for the exhibit.
10. Maximum space allocated for the collection is ¼ of an 8-foot table measuring 30" x 96" x 30".
11. The Scale of Points for Collections is in (HB17, Ch. 14, p. 129).

SECTION I Fruits/Vegetables

“GREEN COUNTRY BOUNTY”

Award of Horticulture Excellence

Award of Merit

Eligible for the *Grower's Choice Award*

Exhibits should be at the right stage of maturity for best taste and quality; table-ready for consumption. (HB17, Ch. 14, p.129)

Class 30 - Cucurbita - one (1) entry displayed on a white plate provided by staging.

Class 31 - Cruciferous - one (1) entry displayed on a white plate provided by staging.

Class 32 - Tomato – three (3) tomatoes similar in size with 1 inch Pedicel (stem) attached as well as sepal (the green leaflike top), displayed on a white plate, provided by staging.

Class 33 - Okra – six (6) okra similar in size with stems trimmed to 1/2 inch, displayed on a white plate, provided by staging.

SECTION J Displays

“GRAPHIC LANDSCAPE”

Eligible for *Collector’s Showcase Award*

1. A minimum of five (5) different specimens (cut and/or container-grown) exhibited in individual containers, or the appearance of being individually exhibited.
2. Specimens such as evergreens and some epiphytes not requiring containers must appear as individual specimens.
3. The Display as a whole is a single entry, and only one (1) entry card is used.
4. Specimens should be related, such as all one (1) plant family (Rosaceae, Pinaceae), one (1) genus (*Hosta*, *Paeonia*), similar characteristics (Bromeliad, Orchid, Fern in containers), etc.
5. Advance registration by *October 10, 2023* is required to ensure space is available.
6. Cut specimen containers need not be clear nor identical.
7. While artistic effect is of equal importance to cultural perfection, featured plant specimens must dominate.
8. Placement of the display is the responsibility of the exhibitor.
9. Staging materials, including shelves, frames, blocks, background panel, man-made sculptures, underlays, other fresh and/or dried plant material, etc., are permitted but are used only to enhance plant materials.

10. Each specimen must be correctly and clearly identified with the current scientific designation, and in a manner to easily identify the specimen's location in the display.
11. Individual specimen scores in the display are NOT averaged; the lowest scoring specimen in the display will determine the highest ribbon possible for the exhibit.
12. Maximum space allocated for the display is ¼ of an 8- foot table measuring 30" x 96" x 30".
13. The Scale of Points for Displays is in (HB17, Ch.14, p.130).

DIVISION II EDUCATION RULES

1. **The NGC Exhibit Policies are printed in (HB17, Ch8., p.85).**
2. Education Exhibits may be the work of one (1) individual.
3. For an ***Educational Top Exhibitor Award*** an exhibit must occupy a minimum of eighteen (18) square feet surface area.
4. Exhibits will be staged on a 30" x 96" x 30" table covered with a black tablecloth furnished by staging.
5. Some plant material is required.
6. Exhibits are competitive.
7. Advance registration with the Education Entries Chair is required by *August 10, 2023*.

8. The Scale of Points for Education Exhibits is located in (HB17, Ch.14, p. 130).

Clear, concise presentation - 15 points
Adequate signage - 10 points
Conforms to NGC Objectives - 10 points

DIVISION III BOTANICAL ARTS RULES

1. The NGC rules for Botanical Arts Horticulture are printed in (HB17, Ch.10, pg.91-93).
2. Eligible for the ***Botanical Arts Horticulture Award*** (HB17, Ch. 5, pg. 44, 91)
3. All horticulture must have been grown by the exhibitor.
4. All exhibits must be correctly named by its binomial or currently accepted scientific designation.
5. No additional embellishments (dyes, glitter, spray paint or manipulation such as cutting or twisting) permitted. Materials such as Petal-Proof©, Super Surface Sealer© or hairspray are permitted to prevent shattering of fragile flowers, seed heads, etc.
6. All specimens in an exhibit need to be the same species, variety, cultivar, type or color.
7. Exhibitor may make more than one (1) entry per class, if each exhibit is a different species, variety, cultivar, type or color.

Class 5 - Manipulated Plants – Topiary, grafted cacti, and those whose natural growth has been altered such as lucky bamboo (*Dracaena sanderiana*).

DIVISION IV YOUTH RULES

1. All NGC policies and rules apply. (HB17, Ch. 9, pg, 88)
2. All Horticulture exhibits must be grown by the exhibitor, though plants could be part of a family garden or yard.
3. Combination plantings must have been grown together for at least three (3) weeks.
4. Eligible for *Youth Top Exhibitor Award*.

Section A Flowering Cut Specimens

“STEMS FOR TOMORROW”

Exhibits will have one (1) stem with one (1) bloom. Scale of Points is (HB17, Ch. 14, pg. 129).
