On January 31, 1981, 0830 hours, 93 year old Martha Winters and her 92 year old sister-in-law, Jesse Winters, were found severely beaten in their residence at 536 West Southern Avenue, Phoenix, Arizona. Both women required hospitalization with Mrs. Winters dying as a result of her injuries. The residence had been ransacked with items reported missing. The investigation was pended until recently when the evidence was re-examined and a lead developed through the nationwide DNA database. Further investigation including numerous interviews and additional scientific analysis confirmed the database match and identified Gary Bivens as a suspect.

On August 17, 2010, Gary Bivens was arrested at 1402 East Buckeye Road for the murder of Martha Winters and the aggravated assault on her sister-in-law.

On August 25, 2010, Bivens entered a Not Guilty plea to all charges. The case is currently in pre-trial motions.

On November 23, 1988, Marlin Darton, B/M, 78 years, was found beaten to death with a brick in his apartment.

On December 15, 2009, Kenneth Jackson walked into 20 West Washington and asked to speak with a homicide detective and only to a homicide detective. Upon speaking with a homicide detectives it was learned that Jackson wanted to turn himself in for a murder which occurred 21 years ago. Detective Rodriguez interviewed Jackson and his account fit the investigative report on specifics only the suspect would know.

The County Attorney's Office was advised of the details and supported the arrest of Jackson. He was later booked on one count of first degree murder and one count of armed robbery.

Trial is set for November 15, 2010.



On May 3, 2005, at approximately 0535 hours, an unidentified male was found lying near a business building at 601 South 65th Avenue. Homicide investigators began the investigation and located no eyewitnesses. The victim was later identified as 24 year old Vester Freeman through fingerprints. The autopsy revealed that victim Freeman died from multiple stab wounds.

Fingernail scrapings from the victim were submitted to the Crime Lab and a CODIS hit identified Termaine Lee.

On March 24, 2010, Termaine Lee was indicted by a Grand Jury for his involvement in this homicide. At the time Lee was incarcerated in New Mexico on unrelated charges and has since been extradited to Phoenix; awaiting trial.



Smith was admitted to the Arizona State Prison Complex in Tucson on March 9, 2010. His maximum end sentence is June 18, 2013.

On July 16, 1995, Victim Marsha Norris was found murdered near a dumpster in an alley to the rear of 2029 N 8th Street in Phoenix. The investigation was pended until recently when the evidence was re-examined and a lead developed through the nationwide DNA database. Further investigation including numerous interviews and additional scientific analysis confirmed the database match and identified the suspect as John Cantey.

On February 8, 2010, the case was submitted to the County Attorney's office for charges. On March 26, 2010, a warrant was secured for Cantey for the charges of kidnapping, sexual assault, and 1st degree murder.

On March 30, 2010, Cantey was arrested in Tampa, Florida, by members of the Tampa PD Fugitive Unit, coordinated with the Tampa PD Homicide Unit and MCAO Investigations.

On July 11, 2006, Basilio Guerrero-Monroy left in his vehicle to visit friends and never returned. Basilio's brother-in-law received a telephone call from a kidnapper indicating Basilio would be killed if \$3,000 was not provided for his release. The ransom was collected and paid to the kidnappers who then contacted Basilio's wife in Mexico with a demand for an additional \$5,000. Basilio's wife was not able to collect \$5,000 so Basilio was driven to I-17 and Pioneer Road where he was shot to death and discovered on July 16, 2006. Suspect Saul Ojeda was identified as the shooter based on witness statements. The case was submitted to the County Attorney's office and turned down in September of 2008 due to no reasonable likelihood of conviction based on the evidence presented.

In November of 2008, casings collected from the homicide scene were entered in NIBIN where a match was discovered. The match revealed that this homicide was related to an MCSO homicide which occurred at I17 and milepost 240 on July 7, 2006, whereby Gilbert Ortiz (H/M 26 years) was murdered in a similar manner. It was also discovered that both victims were kidnapped and held together at 2433 West Campbell Road by the suspects prior to their deaths. A physical comparison was completed and concluded both murders were done with the same weapon. MCSO had been working their case and discovered several suspects fled the state to California shortly after the murder. MCSO traveled to CA where they were able to locate and seize the 9mm. The 9mm was compared to the recovered cartridge casings and it was determined to be the murder weapon.

In December of 2009, MCSO Detective Stephen Fax began working with Phoenix Cold Case Detective Jeremy Rosenthal and the Phoenix case was resubmitted.

On April 3, 2010, Suspect Saul Ojeda was arrested in Santa Cruz County, Arizona, for his involvement in this homicide of Victim Basilio Guerrero-Monroy which occurred at 117 and Pioneer Road.

On October 21, 1994, at approximately 1100 hours, a partially nude. unidentified male was found lying in a pool of blood under a picnic ramada in Papago Park. The victim was later identified as 35 year old Eric Harmon through fingerprints. The autopsy revealed that Harmon died from blunt force trauma and had been sexually assaulted. No suspect was identified and the case was pended in 1995.

In 2007, Detective Barry Giesemann requested additional lab analysis on the evidence including the sexual assault kit to be examined for DNA. In October of 2008, information was received from the Lab that there was a CODIS hit from the sexual assault kit which came back to Jeffrey Lockwood. Based on Detective Giesemann's research, records indicated that Lockwood lived less than four miles from Papago Park in 1994. Additional research revealed that Lockwood is a registered sex offender in Oregon and that

he was sentenced in December 2007 to life imprisonment for burglary in Florida.

obtained a confirmation DNA sample, and interviewed him. The suspect denied any involvement. Additional testing ascertained that the suspect's DNA found on the victim matched DNA found on other evidence from the scene. Detective Giesemann submitted the case to the Maricopa County Attorney's Office in the summer of 2009. On December 11, 2009, Suspect Lockwood was indicted by a Grand Jury for first degree murder and sexual assault. Suspect Lockwood is currently incarcerated in Florida on unrelated charges.

In March of 2009, Detective Giesemann traveled to the prison in Florida housing Suspect Lockwood,

During the summer of 2009, the case was re-opened, reviewed, and worked by Cold Case Detective William Schira as part of the 2008-2010 N.I.J. "Solving Cold Cases with DNA Grant." Further forensic analysis identified Valenzuela and linked him to the crime scene.

On December 5, 2011, Suspect Valenzuela was arrested by Phoenix Major Offender Unit detectives at 12146 N. 28th Avenue and later booked into Madison Street Jail on this homicide charge.

On December 6, 2011, second suspect Miguel Torres, Age 35, was arrested by Phoenix Major Offender Unit detectives at 12121 W. Ocotillo Lane in El Mirage and later booked into Madison Street Jail on this homicide charge.


On August 9, 2003, between 1200 and 1400 hours, Victim Phillip Munoz was shot to death inside his girlfriend's home at 5407 W. Granada Road. The case was initially worked extensively by Retired Detectives Petrosino #2529 and Meislish #3624 and evidence was subsequently analyzed, but the case went cold.

During the spring of 2012, the case was re-opened, reviewed, and worked by Detective J.J. Alberta. As a result of this review, Detective Alberta noted a forensic hit which pointed investigators to Suspect Adrian Garcia. Cold Case Detectives Alberta, Rosenthal, and Ramirez followed up on this lead and moved the case to successful resolution.

On June 7, 2012, Suspect Adrian Garcia was arrested at the Maricopa County Jail-Durango Facility (where he was being held on unrelated charges) for his involvement in the 2003 Phoenix homicide of Victim Phillip Munoz which occurred at 5407 W. Granada Road.

This grant afforded the Cold Case Squad the ability to review a large number of cases from the 1990's. As a result of this review, a key piece of evidence was analyzed by the Phoenix Crime Lab and pointed investigators to Suspect Ronald Cortez. Detective Schwartzkopf followed up on this lead and moved the case to successful resolution.

On December 11, 2012, Suspect Cortez was arrested in Chino Valley, Arizona for his involvement in the **1996** Phoenix homicide of Victim Sarah Maxton located at 10300 W. Lower Buckeye Road. Suspect was booked into the Yavapai County Jail and will be brought to Phoenix at a future date to face the homicide charge.



In April of 2014, Detective Dominick Roestenberg reviewed the case as part of a large and systematic effort to review thousands of cold cases, consulted with the Crime Lab, and submitted a key piece of evidence for analysis. In early July of 2016, Detective Roestenberg was notified of a DNA hit to this key piece of evidence which implicated SP Micah Smith. As Detective Roestenberg was moving towards apprehending/arresting the suspect, he was notified that SP Smith had died in an unrelated incident on July 5th, 2016. Case solved and cleared.



On February, 2nd, 2012, the Phoenix Police Department responded to a call of a dead body at the Pine Wood Apartment Complex located at 4802 North 15th Avenue.

Upon arrival responding officers located the partially burnt body of a white male inside a dumpster. This male was later identified through fingerprints as Alton Eugene Oakland (age 52). It was later determined at autopsy the victim was stabbed two times in the neck, had signs of strangulation, a bilateral neck fracture, rib fractures and thermal injuries.

The case was originally extensively investigated by Detective H. Lopez #7468, however eventually went cold.

In April of 2017, a scheduled five year review of the case was completed by Detective Roestenberg #6773 of the Homicide Cold Case Unit. Through additional follow-up investigation and forensic testing, James was identified and later arrested for his involvement in this horrific crime.



On January 23, 2018, an indictment was obtained on James Hurley for one count of murder in the second degree pursuant to 13-1104 a class one felony.



On September 5, 1982 between 1600 and 1830 hours, elderly Victim Sally Bryant was stabbed to death while in her home located at 1325 W. Hadley Street. The suspect ransacked her house and removed items from the home.

In January of 2012, Cold Case detectives reviewed the case as part of a large grant with the N.I.J. and items were submitted to the Crime Lab for analysis. The evidence was re-examined and a lead developed through the nationwide DNA database. 

In June of 2009, a U.S. Marshal stationed in Phoenix contacted Det. Mark Armistead (ICAT) looking for more information on Suspect Roger Cook. Through skilled research, Det. Armistead tracked the suspect to a facility in Long Beach, California. The U.S. Marshal in Phoenix worked with his counterparts in California to arrest the suspect without incident. During the arrest, the suspect admitted that he was the subject in the 1987 homicide booking photograph. Suspect Cook was booked into Orange County Jail in California.

On August 3, 2009, Suspect Roger Cook was arrested by U.S. Marshals in Long Beach, California, for the murder of Terrance Keenan and extradited to Phoenix. This was a collaborative effort between Phoenix Police Department Cold Case/ICAT homicide investigators and the U.S. Marshals Service.

On October 7, 2010, Roger Cook pled guilty to Manslaughter and was sentenced to 7 years DOC. He is currently serving his sentence in Arizona State Prison Complex, Tucson Health Unit.

Further information indicated that he had staged his own death to escape justice. Over the next few months, detectives from the Violent Crimes Bureau Homicide Cold Case Squad and Major Offender Bureau teamed up with investigators and prosecutors from the Attorney General's Office (who formally worked the case in the 80's) to verify this information and ultimately ensure that the prosecution of this large case could proceed.

On June 1, 2011, Suspect Robert Arcieri was arrested in Palm Springs, California by the PPD and AG's Office team on this outstanding warrant from 1987 charging him with 17 counts including the conspiracy to commit murder. Arcieri was transported back to Arizona and booked into Maricopa County Jail on this warrant.

In late 2011, the suspect was apprehended by Mexican authorities in Sonora, Mexico and transferred to the custody of federal authorities in México City where the extradition proceedings were held. On June 27, 2012, Suspect Roman Felix was transported to Phoenix Sky Harbor International Airport by U. S. Marshal's and transferred to the custody of the Phoenix Police Department. 

PHOENIX -- A suspect in a Phoenix police cold case will be sentenced this week after a police assistant searching national criminal websites found him in a Textofial.

Phoenix Police Det. James Holmes said 27-year-old Isabel Quintero Rodriguez will be sentenced in Phoenix on Friday after he was recently convicted of the June 8, 2003 murder.

Holmes said Rodriguez was identified by witnesses after he shot and killed 20-year-old Jose Antonio Perez-Lopez at a party in front of a home in north central Phoenix. Rodriguez reportedly fled the Valley after the shooting.

In May 2009, a Phoenix Police Assistant assigned to the homicide unit's International Criminal Apprehension Team (ICAT) was researching suspect names from Phoenix cold cases through various criminal website agencies.

It was discovered that Rodriguez had been arrested and jailed in Cibolo, Texas on April, 25, 2009 for assault.

He was identified through a photograph and when Phoenix police obtained a copy of fingerprints from the Guadalupe County Sheriff's Office, they matched prints on file with the Phoenix Police Department.

Phoenix police detectives interviewed Rodriguez in Texas in May 2009 and in June he was extradited to Phoenix to stand trial for the murder of Perez-Lopez.

Holmes said the arrest and conviction came about through dedication, extensive use of tools and technology by Phoenix Police employees and cooperation between law enforcement agencies.


