3 (a) The objects to be pursued by the company on its incorporation are:

1. To carry on the business of a System Integrator and Service Provider, offering comprehensive integrated technology and infrastructure solutions, including but not limited to the design, engineering, construction, development, supply, installation, testing, commissioning, operation, and maintenance (SITC & O&M) of smart classrooms, ICT (Information and Communication Technology) hardware, digital learning infrastructure, and educational technology systems. The Company shall also execute projects in IT infrastructure, structured cabling, enterprise networking, surveillance systems, unified communication, audio-visual integration, and video conferencing setups.

2. To undertake turnkey and EPC (Engineering, Procurement, and Construction) contracts in the renewable energy domain, including solar PV systems, battery storage solutions, hybrid power systems, and smart grid integration. The Company shall

deliver end-to-end solutions for government and private sector initiatives focused on infrastructure development, digital transformation, and sustainable energy implementation.

3. To engage in the procurement, import, export, marketing, trading, distribution, servicing, and maintenance of ICT products, electronic and electrical equipment, renewable energy systems, software solutions, digital platforms, and advanced technology devices; to establish, operate, maintain, and manage data centres, cloud infrastructure, network operating centres (NOCs), disaster recovery sites, and digital command/control systems; and to function as a project management consultant, system integrator, and managed service provider across the domains of information technology, digital infrastructure, smart education, renewable energy, smart cities, and enterprise technology solutions.

4. To engage in construction and infrastructure development activities including, but not limited to, the planning, design, engineering, construction, renovation, refurbishment, and maintenance of buildings, offices, laboratories, educational institutions, warehouses, industrial premises, civil structures, electrical and mechanical installations, and project sites; and to undertake civil, structural, electrical, and allied works as may be necessary for the execution, implementation, and delivery of the Company's business objectives, service contracts, turnkey assignments, or government/commercial infrastructure projects.

To build and construct works

13.To advertise the products and services of the company by all permissible means including but not limited to the Internet and other electronic media, the press, circulars, posters, exhibitions, periodicals, contests and sponsorship of events.

To participate in exhibition

14.To encourage, organize, promote and participate in exhibition, trade fairs, demonstrations of any kind or variety, cinema or dramatic shows, clubs, associations, movements or activities of any kind or variety likely to promote the interests of the Company.
To establish and maintain agency

15.To establish branches or agencies whether by means of local boards or otherwise anywhere in India or elsewhere at any place or places throughout the world for the purpose of enabling the Company to carry on its business more efficiently and to discontinue and reconstitute any such branches or agencies.
To acquire membership

16.To acquire and secure membership, seat or privilege either in the name of company or its nominee or nominees in and of any association, exchange, market, club or other institution in India or any part of the world for furtherance of any business, trade or industry.
To provide for welfare of directors, employees

17.To provide for the welfare of the Directors, ex-Directors, employees or ex-employees of the company or its predecessors in business and the wives and families or the dependents or connections of such person by building of bonuses, dwellings or quarters or by grants of money, pensions, gratuities, allowances, bonuses, awards, profits-sharing or other schemes.
To make donations

18.To subscribe or contribute or otherwise assist or to grant money to charitable, benevolent, religions, scientific, national, public, political, institutions, objects or purposes or for any exhibition.

To register and protect intellectual property

20.To apply for purchase, or otherwise acquire, and protect and renew in any part of the world any patents, patent rights, copy-rights, trade marks, designs, licenses, concessions, and the like, conferring any exclusive or limited right to their use, or any secret or other information as to any invention which may seem capable of being used for any of the purposes of the Company, or the acquisition of which may seem calculated directly or indirectly to benefit the Company, and to use, exercise, develop, or grant licenses in respect of, or otherwise turn to account the property, rights or information so acquired, and to expend money in experimenting upon, testing, or improving any such patents, inventions or rights.

To make arrangements with authorities

21.To enter into any arrangements with any Governments or authorities, supreme, municipal, local or otherwise, or any person or company that may seem conducive to the objects of the Company, or any of them, and to obtain from any such Government, authority, person or company any rights, privileges, charters, contracts, licenses, and concessions which the Company may think it desirable to obtain and to carry out, exercise and comply therewith.

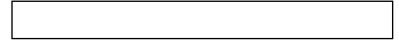
