



Firehouse Sportsplex LLC Liability Waiver & Release

This **Waiver and Release Agreement** (“Agreement”) is made between **Firehouse Sportsplex LLC** (“Firehouse Sportsplex”) and the undersigned user(s), including any minors for whom the User is the parent or legal guardian (collectively, the “User” or “Users”).

This Agreement applies to any and all activities, training, fitness, sports, or related events (collectively, the “Activities”) taking place at or associated with Firehouse Sportsplex LLC, operated by **Adriana Coronado**.

Acknowledgment of Risk

The User acknowledges that participation in the Activities involves inherent risks, including but not limited to physical injury, property damage, or other loss. Participation is entirely voluntary and conditional upon signing and agreeing to this Waiver and Release. The User assumes full responsibility for any and all injuries or damages that may occur as a result of participation.

User Representations

By signing this Agreement, the User represents and agrees that:

1. The User is at least 18 years old, or the legal guardian of the participating minor(s).
2. The User has the authority to sign this Agreement on behalf of themselves and any minors listed.
3. The User is physically able to participate and is not aware of any medical or physical conditions that would limit safe participation.
4. The User is financially responsible for any medical treatment required as a result of participation. Firehouse Sportsplex LLC and its

affiliates are not responsible for any medical or related expenses.

- 5. The User agrees to follow all Firehouse Sportsplex rules, policies, and safety guidelines, including any instructions provided by staff or facility management.**
- 6. The User understands that Firehouse Sportsplex will not conduct any physical examination and will rely on the information provided in this Agreement.**

Release and Waiver of Liability

The User, on behalf of themselves and any minors, hereby waives, releases, and discharges Firehouse Sportsplex LLC, its owners, employees, agents, affiliates, sponsors, contractors, and representatives (collectively, the “Released Parties”) from any and all liability for injuries, damages, losses, or claims of any kind—whether caused by negligence or otherwise—arising out of participation in the Activities or use of the facility.

The User further agrees to indemnify and hold harmless the Released Parties from any and all claims, demands, or expenses (including legal fees) arising from participation in the Activities, use of equipment, or presence on the premises.

General Terms

- This Agreement is governed by the laws of the State of California.**
- This release is intended to be as broad and inclusive as permitted by law.**
- If any portion of this Agreement is found invalid, the remainder shall continue in full effect.**
- The User understands and agrees that Firehouse Sportsplex LLC reserves the right to suspend or revoke facility access for failure to**

follow its rules or safety policies.
