Motion by Reed to introduce an Ordinance of the City of Tecumseh, Nebraska, amending Tecumseh municipal code sections 1-607 to allow electronic posting of general ordinances; section 3-118 to amend the payable date for water billing; sections 6-101 and 6-126 to change the state required annual pet licensing fee; and sections 9-301 and 9-303 to amend the building and plumbing code standard adopted and to approve waiving of the statutory rule requiring that the ordinance be read by title on three different days.
