Water/Waste Water Report- Jeremy Griepenstroh: ② All Routine samples passed. 19 Locates. 2 Read and leave on. 1 Turn off. 1 Turn on. Started New Chlorine pump to test. Repaired 12" main North of Hwy 41 and Hwy 50 intersection. Repaired 10" main ½ mi. North of Hwy 41 and 620 Ave. Keith with Sargent Replaced Valve at water tower. Pumped approximately 27,861,733 gallons, an average of 898,766 gal. per day. ② Approximately 23,059,481 gallons were processed through the wastewater system.

MBA pumped approx. 12,253,368 gallons of wastewater into the treatment plant. TSCI pumped approx. 4,919,975 gallons of wastewater into the treatment plant. Cleaned Clarifier 3 times. Jetted multiple locations. Quarterly Samples for MBA and TSCI.
