Water/Waste Water Report- Jeremy Griepenstroh- All Routine samples passed. 5 Locates. 6 Read and leave on. 1 Turn off. Turn on. Completed Sanitary Survey with NDEE. Hosted a water operator continuing education class. Replaced 2 meters due to freezing. Town tower Valve Actuator failed 2/25. Sargent swapped Valve Actuator from Webster pit to Tower building 2/26. Fixed a leak on the 6" main @ 5th & Sherman. Pumped approximately 21,425,799 gallons, an average of 691,155 gal. per day. Approximately 20,116,579 gallons were processed through the wastewater system. MBA pumped approx. 12,175,425 gallons of wastewater into the treatment plant. TSCI pumped approx. 3,534,261 gallons of wastewater into the treatment plant. Cleaned Clarifier 1 time. Adjusted wasting several times to maintain optimum sample results with fluctuating temperatures. Jetted a couple locations. Received back-up RAS/WAS pump.

Utility Foremen's Report – Doug Goracke: <u>Still</u> waiting on final award for Grid Grant. Sterrup coming in this week to construct addition. Ordered Street Light poles for Arrowhead Drive.
