June 3, 2024

The Board of Public Works of the City of Tecumseh, Nebraska met in regular session in the Utilities Conference Room, Council Chambers on the 3rd day of June, 2024 at 4:00 p.m., in a publicly convened session, the same being open to the public and having been preceded by advance publicized notice, a copy of the same showing the advance time by which such advance publicized notice was given, a statement of how the availability of an agenda of then known subjects was communicated and the time and specific place of the holding of this meeting. Each member was previously furnished with a copy of said advance publicized notice, the same having been transmitted to each member simultaneously with its publicized notice. The Chair presided and the City Clerk recorded the proceedings.

The following members of the Board of Public Works were present: Mark Badertscher, Charles Murphy. Absent: Dan Blessing. Others present: 3 staff members.

Meeting called to order at 4:00 P.M.

Vice Chair Badertscher read the statement of availability of current copy of the Open Meetings Act.

Minutes of the May 20, 2024 meetings were provided to members. Motion by Murphy, second by Badertscher to approve minutes. Voting Aye: Badertscher, Murphy. Voting Nay: None. Absent: Blessing. Motion Carried.

Payment of Bills – Motion by Badertscher, second by Murphy to approve the payment of bills. Voting Aye: Badertscher, Murphy. Voting Nay: None. Absent: Blessing. Motion Carried.

Water/Waste Water Report- Jeremy Griepenstroh: All routine samples passed._20 Locates._1 Read and leave on. 3 Shut-offs._Turned on 3 water services._Pumped approximately 23,311,568 gallons, an average of 751,986 gal. per day. Cleaned South 100,000 gallon Tower. (passed 2 samples and put back online)_Crews have continued replacing water meters and installing modules. Approximately 22,055,396 gallons were processed through the wastewater system. MBA pumped approximately 12,304,107 gallons of wastewater into the treatment plant. TSCI pumped approximately 3,370,413 gallons of wastewater into the treatment plant. Cleaned Clarifier twice. Started UV for the summer. Crews worked on replacing aeration basin piping, cables, and diffusers.

Utility Foremen’s Report – Doug Goracke & Mike Davison: 2 outage service calls. Hoses fixed at Aeration lagoon. Manhole raised at Eastridge. Cleaned up line at Calhoun and 4th. Spraying. Hauled off limbs from storm. Contracts signed for Power Plant Cooling Project.

Consider repairs to sewer line located at Car Wash and Seven Trails Plaza. Motion by Murphy Seconded by Badertscher businesses are responsible for repairs to the lines, will have 30 days to complete repairs. Voting Aye: Badertscher, Murphy. Voting Nay: None. Absent: Blessing. Motion Carried.
