Meeting called to order at 4:01 P.M.

Chair Person Blessing read the statement of availability of current copy of the Open Meetings Act.

Water/Waste Water Report- provided by Tracy Milke: Completed Discharge Monitoring Reports for EPA. Valve at Wastewater Plant that is used to direct flow to lagoons broke. HOA replaced the high-level float at the lift station. Bulbs were changed out on UV system and it is now up and running. The touch screen for the computer system at the Gas Building not working. Have a used touch screen on order, new touch screen system is at least 4 months out.

Utility Foremen's Report – Doug Goracke and Mike Davison provided the report: Fixed pond dam at well field. Started moving material from old tin shed behind power plant. Reset street light pole at Jackson Street. Jet/Vac for Burr. Jet sewer on Broadway between 8th and 9th.

Consider pay increase for Mayor/City Council/Board of Public works members. Motion by Blessing, second by Badertscher to recommend \$5,000/Mayor; \$4,000/Council & BPW. Voting Aye: Badertscher, Blessing, Murphy. Voting Nay: None. Absent: None. Motion Carried.

Review and Consider a resolution to revise electric rates for the City of Tecumseh, Nebraska. Blessing Introduced Resolution 22-1, Badertscher second motion to approve resolution as presented with 3% increase on Electric rates. Voting Aye: Badertscher, Blessing, Murphy. Voting Nay: None. Absent: None. Motion Carried.

Consider transfer of \$287,372.25 plus additional 5% held for retention, when audit is complete from Hwy 50 Project reimbursement. Currently funds are in E&W 0547. Motion by Badertscher, second by Murphy to transfer ½ of total to Sewer 5808 and ½ to E&W 8847. Voting Aye: Badertscher, Blessing, Murphy. Voting Nay: None. Absent: None. Motion Carried.
