Water/WasteWater Report- Jeremy Griepenstroh: All routine samples passed. 11 Locates. 2 Read and leave on. 2 Turn offs. Winterized all buildings and turned heaters on. Replaced heater in Well 1. Pumped approximately 18,904,399 gallons, an average of 609,819 gal. per day. Approximately 18,345,552 gallons were processed through the wastewater system. MBA pumped approx. 10,096,705 gallons of wastewater into the treatment plant. TSCI pumped approx. 6,471,132 gallons of wastewater into the treatment plant. Cleaned Clarifier 2 times. Drained tanks,and turned on heat in gas building. Jetted multiple locations. RAS/WAS Wetwell transducer and prison pit transducer were replaced by HOA. Lagoons were filled.

Utility Foremen's Report – Doug Goracke & Mike Davison- Generator units to be tested the 1st week in December, if tests are good ship the 12th or 13th. Boring done for 2400V relocation at Hospital.
