BECOME AN OFFICIAL SPONSOR

Corporate sponsors allow us to move the needle forward faster and more efficiently.

There are two ways to support :

- Directly through the institutions account in Haiti, and
- through C.H.F. Foundation.

C.H.F Hospital and E.M.P.C.J are independent partners of C.H.F.F.. Therefore, tax deductible receipts for donations made directly to them in Haiti are not available.

The second way to support our partner hospital and school is through C.H.F. Foundation. We are a 501c3 nonprofit organization in good standing with the I.R.S. Tax deductible receipts are available for donors.

70% goes to Haiti to our partner school and hospital to be used for highest needs unless it is a restricted donation.

- Restricted donations for the hospital, school and foundation are donations made to support specific programs as indicated by the donor. There, cannot be used towards highest needs.

30% of every donation stays in our U.S.A. bank accounts, unless it is a restricted donation for the foundation itself.

- 20% is used for program development for Haitians by Haitians.
- 7% program operational costs,
- 3% is used for the foundation's administrative costs .
