**ATTENTION: The High Commission of India Ottawa**

Dear Mrs. Narinder Chauhan, Deputy High Commissioner,

I am an Indian of foreign birth, and the country which I was born in (Canada) has been persecuting me.

It was brought to my attention, by my legal team, that I should write directly to the Prime Minister of India, and to the Indian High Commission as legal remedies in Canada have failed me.

Both of my parents were born in India, and my father was the first one from my family to immigrate to Canada. He first arrived in Canada in 1927, and throughout his lifetime, even after becoming a citizen of Canada, he maintained a close relationship with his mother country and visited India virtually every year, and stayed there for 4 months during most of those visits. My three eldest siblings, from my father's first marriage were also born in Canada but received most of their education in India.

I have wanted to return to the country of my father's birth for some time, and have my children accompany me so that they could visit the birthplace of all of their grandparents while I am still alive.

Over the past decade I have faced an unprecedented amount of persecution from the Canadian Government, and various other Government Agencies, which include but are not limited to The Royal Canadian Mounted Police.

I have very recently filed a lawsuit against two of the culpable parties. In a previous lawsuit that I filed the United States of America in the State of Washington (in February of 2007). Both the Canadian Government and The Royal Canadian Mounted Police settled the matter voluntarily without going to trial.

This current round of persecution includes the issue of a 'on again off again' Warrant for my arrest which is preventing my travel to India and other foreign countries.

The draconian and illegal manner in which I am being persecuted has garnered international attention, and it truly is sad and shocking that in a country where my father and myself throughout our lifetimes, in our personal capacities, and through corporations and Trusts have paid tens of millions of dollars in taxes, would allow this type of persecution to continue.

My children also have not escaped the wrath of those that have chosen to try and intimidate me, and this has caused much pain and grief to me personally, and has impacted my relationship with them.

Furthermore I need to travel to London, England, and Mumbai, India, (among many other destinations), to meet with attorneys in order to prosecute certain of the lawsuits that have been filed already, and to prepare for upcoming litigation that will further illuminate for the world to see what I have had to endure. Not only have I had to endure this but those that have supported me in Canada have faced many travesties of justice.

I believe that this latest attempt to stifle my travel has been done to prevent from the truth coming out, and I have attached to this letter many of the relevant documents, and websites that outline what has occurred over the past 13 years. There are certain high

ranking individuals with fiduciary obligations that continue to benefit by silencing the truth.

While this persecution by the country in which I was born in is highly unusual and extraordinary, I am still hopeful that these matters can be resolved, so that I may continue to conduct my business affairs around the world without threat from the Canadian Government.

I write to inquire if your office would be able to assist in any way to help expedite matters in my capacity as a Non-Resident Indian.
