ARTICLES OF INCORPORATION

of

"VULCAN MANUFACTURING COMPANY, INC."

KNOW ALL MEN BY THESE PRESENTS:

That we, a majority of whom are residents of the Philippines,  
have this day voluntarily associated together for the purpose of  
forming a corporation under the laws of the Philippines

AND WE HEREBY CERTIFY:

FIRST: That the name of the said corporation shall be the  
VULCAN MANUFACTURING COMPANY, INC..

SECOND: That the purposes of which such corporation is formed  
are:

PRIILARY PURPOSE

a. To engage in the manufacture and selling of sole attaching  
cement, industrial glues, shoe polishes, leather dressings and dies  
and other products essential to the shoe & leather goods industries  
and to conduct and carry on all business appertaining thereto;

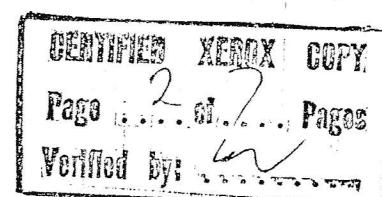
SECONDARY PURPOSE

b. To purchase, lease or otherwise acquire such equipment, tools,  
materials and supplies as may be necessary for the establishment and  
operation of the business in which the corporation is engaged;

c. To purchase, lease, or otherwise acquire such grounds and/or  
buildings as the corporation may need for offices, storage rooms,  
display and sales rooms, or other purposes as said corporation may  
desire and, whenever necessary and proper to sell, convey, mortgage,  
encumber, or otherwise dispose of the same;

d. To engage the services of such workers, employees or agents  
as may be desired or needed in the conduct of the business of the  
corporation;

e. To acquire and undertake the whole or any part of the business,



goodwill, rights, franchise, property and assets of any person, firm or corporation carrying on or proposing to carry on any business which the corporation is authorized to carry on, or owning property necessary or suitable for the use of the corporation, and, as part of the consideration of such requisitions, to undertake any and all of the liabilities of such person, firm or corporation;

f. To borrow money, to issue bonds or debentures secured by mortgage or mortgages, and to execute promissory notes and evidence of debt of all kinds;

g. To purchase, sell, hold, exchange or transfer or otherwise deal in shares of its own capital stock, bonds or other obligations from time to time to such extent and in such manner and upon such terms as its Board of Directors shall determine; provided that the corporation shall not use any of its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of the capital of this corporation, and provided further, that the shares of its own capital stock belonging to this corporation shall not be voted upon directly or indirectly;

h. To have one or more offices out of the Philippines; to procure the corporation to be registered or recognized or to be permitted or allowed to carry on its business or any branch or branches thereof in any state, territory, or possession of the United States of America, and in any other foreign country or place; and in carrying on its business to do any and all acts and things and exercise any and all powers which a natural person could do or exercise which now or hereafter may be authorized by law;

i. To perform all and everything necessary and proper for the accomplishment of the purposes, or furtherance of any of the powers above set forth, either alone or in association with other corporations

to do every other act or acts incidental, or appurtenant with the aforesaid business or powers, or any

The preceding clauses shall be construed and interpreted as both purposes and powers, and the matters expressed in them shall, except as otherwise expressly provided, be in no wise limited by reference to or inference from the terms of any other clause, but shall be regarded as independent purposes and powers; and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning in general terms of the general powers of the corporation, nor shall be expression of one thing be deemed to exclude another not expressed, if it be of like nature.

THIRD: That the principal office is at 116 Nueva Street, Manila, and the factory at 510 Aurora Blvd., Cubao, Quezon City, Philippines.

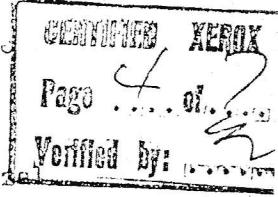
FOURTH: That the term for which this corporation is to exist is FIFTY (50) YEARS from and after the date of its incorporation.

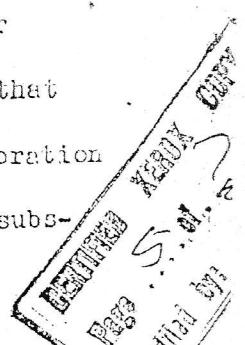
