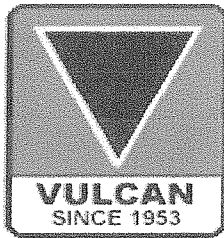
The foregoing premises considered, we respectfully request that the attached GIS 2014 be deemed sufficient compliance with the Commission's requirements.


