News from Tom Hockensmith Chair, Polk County Board of Supervisors

Polk County, Iowa is working with the Cities of Des Moines and Pleasant Hill to study and develop a plan to improve the Easton Boulevard corridor from Fourmile Creek to NE 56th Street. The corridor study will review existing traffic volumes, crash history, and adjacent land uses. The corridor serves as an east/west collector roadway for neighborhoods that feed schools, businesses, and connect communities.

The corridor study will make recommendations on transportation modes to be accommodated, such as vehicles, bicyclists, pedestrians, and transit. Intersections with side streets will be evaluated for alternative configurations and traffic control. The curve located at the intersection between NW 38th Street and Easton Boulevard will also be reviewed for adjustment to bring the roadway alignment into current design standards. A high level review of potential environmental constraints will also be part of the corridor study. Concepts will be developed along with estimates of cost to convert the corridor from the two-lane urban roadway into the recommended roadway resulting from the corridor study.

The time anticipated for the corridor study is approximately three to four months. Thank you for the opportunity to provide an article for this Newsletter

Thank you for allowing me the opportunity to again contribute to your newsletter. I am so proud to represent the NE quadrant of the city. I am especially proud of the

dedicated city employees for making my job representing you so easy. In May our own Public Works Director, Jonathan Gano, was recognized by the American Public Works Association (APWA) as a 2023 Top Ten Public Works Leader. Jonathan is dedicated to improving the quality of life in our community through the advancement of public works services and technology.

Public Works is responsible for the City's sanitation, streets maintenance, forestry, sewer operations and stormwater management while also operating the Des Moines Metro Wastewater Reclamation Authority (WRA). Brook Run has lost a lot of Ash trees due to disease and Jonathan has done an outstanding job with Forestry and Trees Forever (a local nonprofit) to get new trees planted in Brook Run.

The Department of Public Works provides day-to-day maintenance of the City's infrastructure services in the areas of enterprise sewer maintenance and facility operation; levee reconstruction for Birdland and Central Place; sanitation, street maintenance, city storm and sanitary sewer operations; and emergency response for snow and ice, flood mitigation, and windstorm mitigation.

Jonathan is one of many hard-working dedicated city employees. We are all aware of the flooding potential Brook Run experiences and thanks to our City Engineer Steve Naber and Jonathan Gano we are working on solutions. The city listened to your concerns, and we now have two new storm basins that will help in mitigating flooding in the neighborhood.
