

Lakeview Learning & Lakeview Academy

2025–2026 Tuition & Fees Terms and Conditions

The following terms and conditions outline the financial commitments and obligations associated with enrollment at Lakeview Learning and Lakeview Academy for the 2025–2026 school year. By registering your child(ren), you agree to adhere to the payment schedules and tuition rates outlined in this agreement and invoicing.

Please review these terms carefully to ensure you understand your responsibilities and the provisions related to tuition, deposits, fees, and payment plans.

1. Tuition Payment

Tuition payments are due according to the selected payment plan. Families are responsible for ensuring payments are made on time. Late payments may result in late fees, a pause in participation, or withdrawal from programming.

All tuition payments already made are non-refundable. In rare cases of unforeseen circumstances—such as relocation or medical emergencies—Lakeview Learning and Lakeview Academy may consider exceptions at their discretion.

2. Installment Payments

Families who choose an installment payment plan will incur an additional charge of 3% of each transaction to cover administrative and processing fees.

For example, a \$376 installment would include an additional \$11.28 fee (3%), making the total payment \$387.28.

3. Family Registration Deposit

A non-refundable **Family Registration Deposit** of \$50 is required at the time of registration. This yearly per-family deposit reserves spots and ensures a place for students and one chaperone during 30 weeks of programming. This deposit will go toward total tuition for the year.

4. Prorated Payments

Students enrolling after the start of the programming will have their tuition prorated based on the weeks of participation remaining. The Family Registration Deposit remains unchanged.

5. Financial Responsibility

The parent(s)/guardian(s) entering the payment arrangement is(are) financially responsible for

all tuition and fees. Lakeview Learning and Lakeview Academy reserve the right to take legal action to recover any outstanding balances.

6. Withdrawal Policy

If a student withdraws from Lakeview Learning or Lakeview Academy during the school year, tuition for the current month remains due in full and is non-refundable. Any future scheduled payments will be canceled as of the official date of withdrawal.

7. Late Payments

If a balance remains unpaid more than five days past the due date, a \$25 late fee may be applied. Continued late payments may result in a pause in participation until the account is current.

8. Returned Checks

Any returned check will incur a \$35 fee. After two returned checks, Lakeview Learning reserves the right to require all future payments to be made by cashier's check, money order, or credit card.

9. Communication

All communication regarding tuition payments, including reminders and notices, will be sent to the email address you used to make the Family Registration Deposit. It is the responsibility of the parent(s)/guardian(s) to ensure this email address remains current and is checked regularly.

10. Amendments

Lakeview Learning and Lakeview Academy reserve the right to amend these terms and conditions as necessary. Any changes will be communicated in writing to the parent(s)/guardian(s) at least 30 days before taking effect.

11. Acceptance of Terms

By paying the Family Registration Deposit and entering into this agreement, the parent(s)/guardian(s) acknowledge that they have read, understood, and agree to abide by these Tuition & Fees Terms and Conditions.
