Below is the policy for applicants of the low-cost spay/neuter clinics for cats belonging to the general public:

- As the registered owner you must pay the agreed upon fee, in cash, prior to the issuance of the certificate used for the surgery appointment or the application becomes invalid.
- The certificate for the veterinary clinic is valid for **90 days after issue and covers only the spay/neuter procedure and identification tattoo.** A tattoo is mandatory and will follow our veterinary procedure utilizing "PE__"
