Recent Diagnostic and Therapeutic Advances in the Biomedical Research and Clinical fields for Type 1 Diabetes Mellitus


Type 1 diabetes mellitus (T1DM) is one of the most common life-threatening chronic diseases in children and youth, across all cultural and socioeconomic diverse backgrounds. This is an autoimmune disease, in which a person's immune system induces a cascade of self-destructive mechanisms in the insulin-producing pancreatic beta-cells. In the absence of insulin, cells are not able to take up glucose and convert it into energy, a process which is essential for the survival of the human species. Although, in the past 4 decades there has been an increase in T1DM patient survival rates, there is still an estimated decrease in life-expectancy by an estimated 13 years.

The incidence of T1DM has increased worldwide, as indicated by the annual number of 18,436 newly diagnosed youth suffering from this debilitating disease. In recent years, an even more alarming increase in the incidence of T1DM has been found in children younger than 5 years of age. In search of the etiology of T1DM, the biomedical scientific field has recognized that there is an interconnection between genetic predisposition and triggering environmental factors (i.e. viruses, toxins, pollution, & dietary factors) which concomitantly are contributing to the rapid development of T1DM during infancy, childhood and youth.


Clinical management of T1DM serves to be a major challenge due to the increase in incidence of other comorbid diseases, including autoimmune thyroid disease, Addison's disease, gastrointestinal motility disorders, celiac disease, bone impairment and systemic lupus erythematosus. Consequently, T1DM-comorbidities function to reduce even further the quality of life and increase short-term mortality (rapid death) in young patients. In addition to the standard insulin therapy, pancreatic and islet transplants have been the focus of long-term therapy. However, the decrease of graft survival rates over time has necessitated the development of alternative therapeutic interventions. Recent biomedical discoveries in the areas of molecular genetics and stem cell research have revealed that there is a potential for developing medicines and an adequate quantity of human insulin-producing beta cells to sustain therapeutic efficacy in transplantation, repair of pancreatic cellular damage and ultimately, healthy levels of insulin production.


For the betterment of human life and advancement of clinically applicable knowledge, it is vital to support biomedical research in T1DM, such that an early diagnosis of T1DM can be made that will subsequently lead to efficient use of preventative and regenerative therapies needed to restore glycemic control within the 'critical window' of therapeutic opportunity. This will enable the medical field to meet the milestones that are imperative to increase both the life expectancy and quality of life in our young and adult T1DM patient populations, who have every right to enjoy a fulfilling life.
