



Type I Diabetes Mellitus/ Juvenile Diabetes

❖ What is T1DM or Juvenile Diabetes?

Juvenile means “young or immature” and Diabetes means “human body lacks production of insulin under influence of internal or external factors”. Type I Diabetes Mellitus also known as Juvenile Diabetes is the condition where the immune system of the human body destroys its own insulin producing cells (B-cells) in the pancreas and results in uncontrolled rise of blood glucose levels. Juvenile Diabetes is different from the Type II Diabetes Mellitus. In case of T2DM the body produces less amount of the insulin due to which there is alteration in the blood glucose levels (JDRF, 2014).


Type I DM is categorized into autoimmune Type 1A DM and idiopathic Type 1B DM. Juvenile Diabetes is not hereditary disorder and also have low degree of genetic predisposition (KD Tripathi, 2014).

❖ Role of Insulin in our body

Insulin is hormone secreted by B-cells of pancreas. Insulin helps in producing lipids and protein. It plays an important role in controlling the glucose levels in our blood. Involvement of insulin in production of lipids helps to maintain balance of the ketone bodies which act as energy source for heart and muscles. The increase in ketone bodies may cause ketonaemia (more ketone in blood) and ketonuria (more ketone bodies in urine).

❖ Basic signs of T1DM

Increased appetite	Frequent urination
Increased thirst	Sudden weight loss
Changes in vision	Lethargy
Heavy breathing	Sugar in the urine

❖ Treatment and Prevention


T1DM cannot be cured or prevented. It may occur to anyone, of any age especially children.

For juvenile diabetes, treatment is basically to maintain the targeted blood sugar level (BSL). **Insulin** injections are first line therapy used to control the BSL in T1DM patients. First insulin was produced by Banting and Best, 1921 in Toronto, Canada (KD Tripathi, 2013). Hence, the regular insulin is also known as Toronto Insulin. Currently, the research is targeted to produce drugs which can provide breakthrough in treatment of Type I Diabetes Mellitus.

Current research shows that the juvenile diabetes can be treated or may be controlled by either blocking our immune system to attack B-cells or to inject B-cells with the protective layer which stays unharmed by our immune system. Along with that, development on different route of administrations for insulin is focused such as insulin patches or tablets (JDRF, 2014).

❖ Lifestyle and Dietary changes in Juvenile Diabetes

- Check your blood sugar level often (6-8times/day)
- Keep up with the facts of the diabetes
- Do know your equipment either insulin injections, pre-filled syringes or glucose meter
- Inject insulin shots as required and use on regular basis without skipping any dose
- Follow healthy diet plans to keep your BSL under control
 - Eat 3 meals per day (Healthy diet)
 - Include little amount of starchy carbs in every meal but don't make it as main course of meal (Keep a track of your carbs intake)
 - Eat more fruits and vegetables and include them in your meal with beans (High protein food should be included in your healthy diet.
 - Avoid fats in your diet
 - Limit the sugar or sugary intake
- Talk or consult with the dietician to know more about healthy diet plans
- Do exercise on regular basis (Body weight will be maintained and you will stay active)
- Do change the working habits (Stress may increase blood sugar levels)
- Avoid alcohol consumption and stop smoking
- Don't eat packed bags of chips or food
- Don't drink regular soda or sweetened drinks unless you are hypoglycemic (low blood sugar)
- Don't skip meals as it may lead to over eating on next meal and may result cause hypoglycemia
- Always routine your diabetes check-ups with the physician.
