

## **HOW TO APPLY FOR FINANCIAL AID**

Families in need of financial assistance are invited to submit a request for financial aid by completing <u>one of the following options</u>: an online application using the standardized FAST application or a written application directly to the preschool office. Each option is described in more detail below:

Option 1: ONLINE FAST APPLICATION You may apply for financial aid by filing an online application through the Independent School Management Financial Aid School Tuition (FAST) Program in Wilmington, DE. FAST provides the Preschool with a need-based financial aid analysis service that ensures that our process for establishing financial need adheres to nationally established standards of best practice. All information from FAST is kept confidential, as is all information pertaining to a family's financial aid request. The FAST program is flexible in terms of the information it will accommodate, thus allowing families to accurately represent their own particular circumstances. FAST provides a 24/7 help desk or online email to answer any questions that may arise. The charge for the FAST application is \$48.00 which is paid by credit card at the end of the session. Upon paying this fee, Christ & Holy Trinity Preschool will waive (or credit back if already paid) our \$250 registration fee. To start the process, click HERE.

After completing the online application, you will be required to submit your most recent tax returns for both State and Federal taxes with all schedules and W-2's to:

 Option 2: WRITTEN APPLICATION You may also file for financial aid by submitting the enclosed written application and necessary documents (your most recent State and Federal taxes with all schedules and W-2's) directly to the preschool office:

All information provided to the Preschool will remain confidential. Financial aid information is reviewed by the following members of the Preschool Governance Committee: Preschool Director, Committee Chairperson, Preschool Treasurer and Rector of Christ & Holy Trinity Church.

Financial aid may be awarded in the form of a tuition grant, payment plan or both and applications for the 2022-23 school year are due on **Friday**. **December 10**, **2021**. Notification of financial aid will be sent via email on **Friday**, **December 17**, **2021**. We recognize that some families may enroll in the preschool after the financial aid deadline has passed and that financial hardship may arise unexpectedly during the school year. Therefore, you are invited to apply for financial aid at any time to be considered for any scholarship funds that may still be available after the December 17, 2021 deadline.
