1. Treasurer's Report

- Presented by Mark Hansen:
 - Two transactions:

2. Three Club Run Recap

- Pete and Matt attended to engage clubs and encourage participation.

4. Upcoming Events & Volunteer Needs

8. BRC Update (William Schuster)

- Monitoring single track trail reopenings, Snake East area planning.
- Discussion on federal travel planning timelines and land swaps.
- Potential use of BLM's "Lands Potentially Available for Disposal" tool.
- Noted outdated land use plans in several regions.

9. Legislative & Conservation Items

- Monitoring public land monetization proposals (e.g., Natural Asset Companies).
- **Washington HB 1198**: Proposed diversion of ORV sticker funds to general state fund—potentially problematic precedent.
- Grizzly bear delisting as endangered—public comment open until May 16, 2025.
