Matt,

For the record, although Deborah and Chris suggested we could move forward with only the right deacceleration if we limited our events to 35 per year, Louie and I haven't agree to this thus far. As I stated in my email following our call, Louie and I wanted to stay the course and have the in-person meeting. Our original goal for the meeting was to better understand Chris and Deborah's request for the additional turn lanes as it relates to the SHAC, crash data, and our management plan. In addition, we now need to understand their rationale for limiting the number of events to 35 per year. Our concerns are as follows:

- 1. The number of events per year shouldn't matter. We believe we can safety host events and manage traffic flow whether there are 5 events or 100 events.
- 2. By limiting the number of events to 35, Chris and Deborah are asking us to limit our revenue and profitability. This, of course, raises the question are any of the other venues currently operating in Douglas County required to limit the number of events they host each year?
- 3. During the call, you mentioned that in addition to limiting the number of events to 35 per year, we would also need to amend our Special Use Permit should we want to increase the number events. As you know, the process to date has been rather unpleasant and extremely time consuming. The thought of going through this process

again seems unreasonable. Again, are any of the event venues currently in operation in Douglas County required to amend their Special Use Permits (if they have them)?

No need to respond. We look forward to discussing further on Wednesday. Take care.
