

Rules – Village of Coloma Gingerbread House Building Contest Saturday December 2nd, 2023

Need not be present to win. Entries can be individuals, families, businesses, or organization.

Please do not place name on your entry, instead, a number will be assigned to each entry at the time of drop off.

Entries should be dropped off anytime between the hours of 8 am – 8:59 am on Saturday December 2nd, 2023 at to qualify for judging. LOCATION: COLOMA ELEMENTARY SCHOOL

- 3 winners, as selected by the judges and community will receive a prize. One winner will be selected for the adult category (ages 12+), one winner will be selected from the children's category ages 0-12, and one winner will be selected from the group category.
- Apart from the base, like a cookie sheet, all entries must be 75% edible with the major components (such as walls and roof) made of gingerbread or similar cookie like material (graham cracker). They can be decorated with candy or other edible embellishments.
- Entries must fit on an 18" x 18" base.
- Construction can be of any type of structure – each entry is given the opportunity to be as creative as they wish to be. All structures need to comply with width and length guidelines. Gingerbread structures may be houses, train stations, barns, birdhouses, lighthouses, bridges, ships, or other imaginative dwellings. Kits are welcome.
- Judges decisions are final; winners will be announced on Monday December 4th, 2023 via the Flyte Family Farms Facebook page.
- Judging Categories Adult, children, and group.
- All entries must be dropped off, completed and ready to be judged by 8:59 am on Saturday December 2nd, 2023. Judging will begin at 9:00 a.m. and conclude at the end of the vendor show.

You may pick your Gingerbread House up Saturday December 2nd between 3:00 p.m. – 3:30 p.m. at the Coloma Elementary School. If you choose to leave your entry for display it will be disposed of after the Holidays unless other arrangements have been made.

Winners will be announced on Monday at Noon on the Flyte Family Farms Facebook page and on the Coloma Community Calendar page.
