





GIVE A GIFT OF LIFE/ BOOK GIVEAWAY

While being deployed to Juvenile Hall during the covid-19 crisis in 2020, I began to assist with supervision on a regular basis with the youth detained in the High Risk Compound at Barry J. Nidorf Juvenile Hall. I began to communicate and create good working relationships with the youth in the compound. I was going to school with them daily and they were asking me so many questions. I began to share conversations with them and began to share inspirational, spiritual, motivational and occupational books and information with them.

I personally handed each book to each youth, taking time to speaking to them about their family and goals in life. Giving them some words of life and encouragement to see past their situation and attempt to create a vision for their life, once released. I explained to them on how to model their life pursuits, learn to network with prosocial adults in their families and community, seek prosocial adults and build or confront their mental, spiritual, and physical well-being. Then I began to work on their relationships with their families. All this in about five minutes time. The visits were happening weekly and regularly until I was no longer deployed to juvenile hall. These meetings began to become conversation sessions of self-control, making better decision, self-esteem, spiritual strength, and serving people and your community.

After no longer being deployed and returning back to the area office and teleworking, I have returned on a monthly basis, visiting units Y, W, Z AND X to provide them books, writing paper, envelopes and to speak a few words of encouragement. I began to receive book donations from friends who love books, teachers, thrift shops and pastors from community churches.

We recently reached out to Barnes and Noble store in Valencia who are considering providing donations but also placed me in contact with Barnes and Noble customer/community services to inquire about a donation through the corporate office. I thank LACCEA for donating and supporting this program.

In short, we know that these youth who are detained for even the most serious offenses will most likely be released at the age of 25. We can help them seek information and knowledge. Provide a model of how to prepare to be productive young adult in the future, while being detained in the juvenile justice system.

It is hopeful to know that LACCEA will be in the forefront of Change for our Youth, Probation Officer's and Families.

"SHOULD I ASK FOR REPRESENTATION?"

I frequently represent members at various interviews and meetings at the County, State, and Federal levels. Some interviews involve serious allegations and can last for hours while others are short and uneventful. I'm often asked the question by our members, "Can you represent me at this meeting?" The short (and every attorney's favorite) answer is: it depends.

It depends on what the purpose of the interview is and whether the right of representation has attached. Some meetings, such as grievances and mediation, always involve the right to representation (and you should ensure you have representation!). Interviews where you are named the "Subject" of the interview also always involve the right to representation. When you are named the "Subject," you have been designated as the individual who has allegedly committed employee misconduct. Regardless of the allegations known to you (and there may be additional allegations you are unaware of), you should always seek representation. Some members report that they didn't believe they needed representation because the allegations were completely false, only to find that a seemingly harmless statement made by them led to discipline.

Some meetings don't provide the right of representation unless certain circumstances exist. Many members will call and request an attorney be present for a meeting with their supervisor. However, a meeting with a supervisor in which the supervisor is asking normal operational questions does not trigger the right to representation from an attorney (although you may have your Union steward present with you). The meeting must elevate to the point where you are being asked accusatory questions which you reasonably believe can lead to you being disciplined.

Affidavits should generally always be reviewed by a representative prior to submission. It is reasonable to request at least 24 hours to author an affidavit before being required to submit it. If you are required to author an affidavit in response to an accusatory statement or questions about your potential misconduct, then you certainly have a right to have a representative review your affidavit prior to submission.

If you are asked accusatory questions about your own conduct in which you reasonably believe your answers could subject you to discipline, you should respectfully ask to adjourn the meeting so that you can seek representation.

If in doubt, let us help you out! Give our office a call and speak to an attorney to determine whether you have the right to representation at the meeting or interview you're asked to attend.
