


Greetings,

FAMILIES FIRST CORONAVIRUS RESPONSE ACT

LACCEA Members:

During these tough times, we wanted to ensure you are familiar with County resources available to you should you be affected by COVID-19. Federal legislation recently enacted entitled the **"Families First Coronavirus Response Act (FFCRA)"**, which applies to all Government employers and provides for paid and protected leave for those directly affected by COVID-19, or whose children are without school and daycare. However, the County has exempted many of its Departments from this leave by classifying them as "Disaster Workers" or "Essential Government Workers" (such as healthcare and law enforcement). To meet the requirements of the new legislation, the County has created two of its own substantially similar leave programs entitled, **"COVID Paid Leave"** and **"COVID Leave"** for employees of exempted Departments.

The following departments are considered exempt:

- Children & Family Services
- Health Services
- Medical Examiner-Coroner
- Probation
- Public Social Services
- Sheriff
- Fire
- Internal Services Department
- Mental Health
- Public Health
- Public Works

The only difference between the County-created leave programs for exempted department employees – **"COVID Paid Leave"** and **"COVID Leave"** – is that they require the approval of the Department Head or his/her designee (Department HR). All other aspects of these leave programs are identical to the federal leave programs that are available to employees in non-exempt departments.



Donna Wells, Esq.
Attorney at Law

Donna Wells, has been representing LACCEA members since 2010! As a private practice attorney, she's supported our members with her expertise in handling labor, employment and civil rights law litigation, as well as counseling municipalities and public employees on labor issues. We have received numerous letters of appreciation from thankful members.

Although I have been a county employee for 30+ years, this was the first time I chose to participate in this process. I was very apprehensive and a bit unsure. Ms. Wells looked over the documentation I provided, and she explained that although I did not need legal representation in this matter, if I requested her to attend the Mediation Hearing with me, she would do so. In December, Ms. Wells was right by my side at that hearing. She has a relaxed style, she conversed easily with the Deputy Compliance Officer, and this made the process much easier for me, as this matter was of a sensitive nature.

I am grateful for Ms. Wells passion, dedication and professionalism, as well as her legal expertise. I would like to commend the Board of Directors for providing legal guidance to the members as well as excellent legal support and representation."

Previously, Donna Wells was General Counsel at FilmL.A., Inc., a non-profit that coordinates permitting and monitoring of on-location filming for the City and County of Los Angeles. Prior to that, Ms. Wells served as Director of Government Relations for the Motion Picture Association of America, where she analyzed proposed legislation for impacts on the production industry and advocated for film production studios. Initially, she started her career practicing employment law and we are very grateful she came back to her roots!
