SUGGESTIONS FOR HANDLING TWO PREVALENT WORK-RELATED ISSUES

As LACCEA members, effectively handling work-related situations is crucial. This article provides insight and tips for common workplace challenges: tardiness and absenteeism.

TARDINESS:

Occasional lateness due to various reasons is understandable, but consistent tardiness violates County policies and affects productivity. Supervisors and employees should address this promptly through communication and proactive planning.

TAKE ACTION:

Proactive communication with supervisors is key to addressing tardiness or absenteeism. Early explanation of challenges and seeking support can prevent escalation and empower employees to navigate workplace issues effectively.

ABSENTEEISM:

Regular unexplained absence can lead to disciplinary action, impacting departmental operations and morale. Employees should communicate challenges early, seeking guidance from human resources and understanding available leave options, including FMLA or CFRA protections.

CONCLUSION:

Navigating workplace challenges requires proactive communication, understanding policies, and seeking support when needed. LACCEA members can effectively address tardiness and absenteeism by initiating discussions with supervisors, exploring resources, and seeking legal assistance as needed. Remember, LACCEA's legal team is available for guidance and support.

LEGAL ASSISTANCE:

Legal support may be available for absenteeism related to medical or family issues. Employees should understand their rights and seek assistance from LACCEA's legal team if necessary.

Hello Fellow Officers/LACCEA Members,

I am a proud LACCEA member. I began my career with the County as a volunteer, student worker, student professional worker, Group Supervisor Nights, Deputy Probation Officer I, and currently hold the title of Deputy Probation Officer II. I sought the assistance of LACCEA when I was wrongfully terminated. I reached out to LACCEA because of their reputation for being responsive and committed to their members.

The Los Angeles County Probation Department performed a poor investigation into allegations of misconduct without conducting its own due diligence. I contacted the Los Angeles County Chicano Employees Association to help with my matter where I was the party that initiated an investigation and then became the subject of the investigation and then wrongfully terminated.

Once I was notified that I was placed under investigation I immediately called LACCEA and spoke to Attorney Dion DiNome. He is an eager attorney whose work is with the type of people we deal with daily in our Department and has insight into the County and our Department, including its flaws. He immediately advised me on what to do, and what not to do. I utilized Dion because he fights for what is right!!!!

Not only did Dion assist with my matter, but I made a friend who I would have never met if I did not go through this ordeal. My case lasted approximately 4 years, during which I was unpaid. Dion was not only an attorney but became a person/human being that would take my calls at the expense of his own personal time. After all was done, we determined that my Skelly hearing rights were violated at the initial hearing. I was an employee who had no discipline in the 18 years of County service, and Dion was successful in making me whole as an employee.

Dion assisted in keeping me positive even when it appeared that there was no end in the process. LACCEA not only carefully screens their counsel, but the counsel is impartial and will fight for your rights!

LACCEA has my vote of confidence, and I would recommend them to fellow County employees.


