What is included in your trip: You are more than welcome to bring your own gear if you'd like. If not, I can provide you all the gear, bait, fuel, and ice necessary to supply your day of fishing. What is NOT included: Beverages and food are not supplied. (We always have water on board). If bringing sandwiches, we suggest you place them in Ziplock bags to ensure dryness.

Life Jackets: As a USCG certificated vessel, we have enough life jackets on board for all passengers and crew. If you're cruising with children and are more comfortable bringing their own life jackets, please do so.

Shoes: Please wear shoes that are soft-soled and have light bottoms (boat shoes, sneakers, etc.) Guests wearing high heels or dark-soled shoes will be asked to remove them prior to boarding the vessel. As the deck can get hot during the summer months, it's not recommended to go barefoot, so please plan accordingly.

Sea sickness: Sea sickness can occur to anyone; we suggest that anyone who has even the slightest concern about being seasick takes an over-the-counter motion sickness medicine prior to departure. It's cheap insurance to make sure you have the most enjoyable day on the water.
