

BRIDAL MAKEUP Contract

Agreement/Jurisdiction:

The person(s) whose signature(s) appear on this contract, known as "Client", agree that Maria Lemoine Name known as "LEMOINE LOOKS", shall provide services to apply the best of her abilities and knowdledge , in the manner described in this document. This is a binding contract which incorporates the entire understanding of the parties, and any modifications must be in writing, signed by both parties, and physically attached to the original agreement. Client assumes responsibility for all collection costs and legal fees incurred should enforcement of this contract be broken.

Liability:

All brushes, tools, and makeup products are kept sanitary and are sanitized between every makeup application. Any allergies and/or skin conditions should be reported prior to application. The Client agrees to release the Artist from liability for any skin complications due to allergic reactions.

Method of Cancellation/Rescheduling:

In the event of a cancelled or rescheduled event, Lemoine Looks By Maria Lemoine requires a notification in writing 30 days prior to the original event date. If canceltation happens after the 30 day deadline the Client is responsible to pay the full amount. This is the only method of cancellation I will accept.

The down payment is non-refundable in any case of cancellation, due to the reservation of the date and the right of the artist to be able to use that date for another possible client.

Client Responsibilities:

It is the Clients responsibility to provide a safe and adequate working environment for the Artist. The location must include:

- Lots of natural or lamp lighting
- Enough time for the discussed services
- Enough space
- Outlets
- Insurance
- Maintaining clear communication
- Free parking or paid parking that will be billed to the client

Payments:

A retainer fee of half of the collection amount is due at the time of booking; this payment is nonrefundable and must be paid in order to secure your event day. Last half needs to be paid 60 to 30 days before the event day, unless otherwise agreed upon. If event is booked with less timethe rest of

the paymer would be requested prior services.

Payments can be made with E transfers, check or cash.

Travel:

A mileage fee will be charged as follows: 0-20 miles/km = 20\$, Every extra 10-20 miles= 1.50\$ a mile.

Out of state travel have to include: Travel fee, hotel, food.

Photography:

Photos or videos may be taken for promotional use and advertising purposes online and printed material. Full credit will be given to any professional photos and videos taken by photographers and videographers.

Pictures taken by any other outsiders: I just kindly ask for credit in every picture and video taken of the day. as well as any printed or online material used.

I have read, understand and agree to the terms and conditions of this Agreement. Each person signing as Client below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement.
