Executive Director Updates:

- Red Ribbon Week (October 23):
 - Partnering with four elementary schools and all high schools.
 - Secured seven speakers.
 - o Distributing balloon kits for a giant red ribbon display.
 - Collaborating with Isa Tydingco (Cibola student running for Miss Yuma County Teen) on a teen substance use platform.
- Crime Causation and Youth Activities: Youth engaging in pro-social activities are less likely to engage in damaging behaviors.
- Upcoming Events:
 - Health Fair in Walmart (contact: Daisy Cortez).
 - Recognizing Homeland Security on the upcoming radio show.

Henry Gonzalez Presented and Questions/Concerns session with participants:

- o Topic: The rise of fentanyl in Arizona.
- Discussed social workers and school security, Narcan availability, and partnerships with behavioral health organizations.
- o Suggested holding assemblies and activities to engage students on substance abuse topics.
- Anonymous Reporting: Implementing an anonymous app for reporting bullying, drug use, and violence in schools. Jennifer Blackwell asked about that process to share with community.
- Vaping Awareness: Partnering with the Health Department on vaping dangers.
- Strategies for Success Program: Provides school continuation options with social work and mental health support.
- Discussed challenges with providing services for students with private insurance and transportation issues for those attending the program.

Additional Updates:

- Virgil: Embedded counselors in middle schools for military dependents.
- Tricia Chamberlin: CEO of Fort Yuma Indian Health Care Center:
 - Opening public affairs and social work positions.
 - Providing services through their Behavioral Health Program with funding for those without insurance.
 - Partnering to offer services and streamline referrals.
 - Talked about how better to serve their schools and community population as most services are provided onsite.
