- Shelley Mellon, YCADC / YCMHC Chair – Welcome

- Ryan Butcher, Yuma County Public Health District – Overdose Fatality Report was submitted to DHS. Information and presentation will be brought to our coalition in October. Update on all four (4) Naloxone distribution sites. By September, all will have “newspaper style” distribution displays in lobbies, open to the public.
- Beverly Cade, NAACP –
- Dave Cade, Principal, Vista High School - Continuing with the back-to-school initiatives... numbers look strong so far. Any events their students can volunteer for, please let them know.
- Jessica Valadez, AZ Liquor License & Control Dept – Main focus is underage drinking / serving throughout the state. “Nothing major to report, but we’re here to support wherever needed.”
- Lisa Bednar, Arizona Food Marketing Alliance – represent grocery, convenience stores etc. Umbrella program called “BASIC” – focused on underage drinking prevention. Here to support and share messaging.
- Candace Brown, MCAS Yuma School Liaison – Shared resources for Military Family Life Counselors: 6 providers available at several schools. Connecting Military families to resources. Children and adult counseling available.
- Jen Hulbert, Yuma County Public Health District– Shared that they provide Naloxone training Cibola HS. Thanked the coalition for the connection. They also teach Youth Mental Health First Aid. They have a few spots available. They pay for the training.

- Victoria Gonzalez, YCSO and YCJJC – YCSO is seeing a 12% increase in adult incarcerated persons, with drug and mental health being the biggest issues. YCJJC just took over the medical operations. They are looking for support with behavioral health and support services.
- Jordin Aguiar, Onvida Health Behavioral Health Dept – Behavioral health has a dedicated intensive for mental and substance health. Make a referral by calling.

- Beto Garcia, Charlie Health – no updates. Kickball Kick Out Drugs Kickball Tournament.

- Ulises Torres, Social Worker, Gila Ridge HS – Updates: Stats at Gila Ridge. Reentry meetings, crisis meetings 13 meetings last year, 18 school safety plans created, 40 referrals to McKinney rental programs, Integrated Health Care partnership, school bus services for 48 students referred. Over 42 students have been identified as "High Risk Students".
- Several other social workers at local high schools introduced themselves.
- Ramesh Neerpat, Exceptional Community Hospital – Shared that YCACC is a valued community partner. This coalition has a huge impact on the Yuma Community. Help provide Naloxone to our community.

- Jamie Burnett, Arizona Public Health Analyst for the Overdose Response Strategy for the CDC – Plug for “Stop It” Campaign ADE ADHS DDRO HYDA, improve naloxone access to schools.
