# Leva Climate Action and Sustainability Policy

## 1. Introduction

Leva is committed to addressing climate change and reducing greenhouse gas (GHG) emissions. We recognise that climate change poses significant risks to our business operations and our clients, and we are committed to taking action to reduce our carbon footprint.

We will work with clients to identify opportunities to reduce emissions and improve sustainability, including remote working to reduce travel impacts. We will continue to develop our sustainable project management consulting services to clients.

We will educate our employees and partners about the importance of addressing climate change and reducing GHG emissions. We will strive to be exemplars of sustainable business practice. We will continue our global green project management ambassadorship membership.

#### **Cultural and Social Wellbeing:**

We are committed to employment practices that support diversity, inclusion, and equity. We are committed to meeting our obligations under the Treaty of Waitangi.

#### **Giving Back:**
