

Terms & Conditions

(Valid 1 Jan 2025 - 31 Dec 2025) Last updated: 26 Jun 2025

1. Scope & Acceptance

By reserving any service with Able & Fox Tours Ltd. ("A&F", "we", "our"), the client ("you", "your") confirms that all travellers have read, understood and accepted these Terms & Conditions.

2. Services Covered

- Private Guided Tours (Full-Day: up to 9 hrs | Half-Day: up to 5 hrs)
 - o Executive driver-guide, itinerary design, vehicle hire and operating costs
 - Courtesy snacks & soft drinks (max £20 per day / up to 4 guests)
 One collection & one drop-off within a 25-mile radius of SL4 1HT
- **Chauffeur Drive / Hourly Services**
 - o Prepared executive vehicle, professional chauffeur, fuel & taxes
 - Courtesy snacks & soft drinks (max £20 per booking / up to 4 guests)

3. What's Not Included (unless stated in writing)

- Attraction entry fees, theatre tickets or any third-party activities
- Parking, tolls, local Congestion & ULEZ charges (billed at cost)
- Per-diem expenses (£25 full-day | £15 half-day, if applicable)
- Additional driving hours beyond the package (charged at the agreed hourly rate)
- Pick-ups / drop-offs outside the 25-mile radius of SL4 1HT (quote on request)

4. Pricing, Deposits & Payments

- All prices are listed and payable in GBP (£).
- Deposit: 20 % (non-refundable) secures your dates; deducted from the final balance.
- Final balance: due 7 days before the first travel date.
- Accepted methods: UK BACS, international IBAN/OBAN transfer, or Revolut payment link.
- A fully itemised itinerary and invoice will be emailed for electronic signature before any payment is requested.

5. Cancellation & Refunds

6. Date Changes After Payment

- One change free of charge if requested ≥ 7 days before travel and if the new date is available.
- Subsequent or short-notice changes may incur an admin fee or be treated as a cancellation (see table above).

7. Traffic, Weather & Force Majeure

 Delays caused by traffic, weather or events beyond our control may require on-the-day itinerary adjustments. These do not entitle the client to a refund, but we will always propose the best practical alternative.

8. Itinerary Variations

- Route and timing remain at the driver-guide's discretion for safety and operational reasons.
- Guest-requested deviations are accommodated where feasible; substantial detours may shorten or replace scheduled stops.

9. Insurance & Liability

- A&F holds Motor and Public Liability Insurance up to £2 million; certificate available on request.
- Clients remain responsible for obtaining appropriate travel, medical and cancellation cover.
- A&F is not liable for losses, costs or damage arising from circumstances beyond our control once the tour has commenced. If we must cancel in full, all monies paid will be refunded — no further liability shall be assumed.

10. Luggage & Personal Property

- One medium/large suitcase plus one small carry-on per person is included.
- Excess or undeclared luggage is accepted only at the driver's discretion and may incur a surcharge.
- Property is carried at the owner's risk.

11. Child Safety

- UK law requires approved child seats for travellers under 12 years or 135 cm.
- Guests must supply compliant seats; A&F does not provide them.

12. Age-Restricted Experiences

Guests must be 18+ to participate in alcohol-based activities (e.g. distillery visits).

13. Premium & Concierge Services

We can arrange third-party services (hotel bookings, restaurant reservations, charters, fly-fishing, golf teetimes, theatre tickets, etc.). Those services are subject to the supplier's own terms. Any pre-payments we make on your behalf will be invoiced and become non-refundable once confirmed with the supplier.

14. Governing Law

These Terms & Conditions are governed by the laws of England and Wales. Any disputes shall be subject to the exclusive jurisdiction of the English courts.
