# GRANT WRITING FEE SCHEDULE AND PRACTICES



## Single Grant Application

**\$6,000 - \$15,000**

Single grant applications are limited term engagements expressly for the purpose of making a single grant application. Single Grant Proposals are written by Rehab My Rehab team members based on the client and funder specifications for the grant. Price is determined by complexity.

## Grant Source Research

**\$2,500**

Using our grant funding database set, we will search over **240,000 potential funders / corporate giving sources** for your project concept. *Add on telephone surveys and internet research for state and local government for an additional \$2,500.*

## Foundation / Corporate Giving Proposals

**\$8,000**

Comprehensive foundation / corporate giving search for a single project concept. Prepare foundation proposal letter and application for up to 10 matched funders.

## Proposal Review / Editing

**\$2,500**

Single grant review and editing (Up to 10 Hours of consulting services). 10 Hours total - payable in advance, additional hours will be invoiced at \$250/hr.

## SUPERCHARGE YOUR GRANT SEEKING WITH A REHAB MY REHAB RETAINER \$5,000 per month

Rehab My Rehab will conduct grant source research, searching over 240,000 potential funders, and alert you to grant opportunities. In addition, Rehab My Rehab staff will prepare proposals and provide ongoing consultation and advice related to grants. Client will receive weekly progress emails and up to 4 hours of additional phone/teams/zoom or meets support per month. The first payment is due within seven (7) days of executing the agreement, and unless otherwise agreed upon, services will begin on the first business day of the month following the execution of the retainer. Service minimum 3 months. Cancel with 30 days notice after the first 3 months.

### RMR Standard Terms For Grant Writing Contracts

1. Rehab My Rehab does not provide grant writing or editing services on a contingent basis.
2. All grant writing and editing will be performed by a staff member with advanced managerial experience in addiction treatment and or behavioral health treatment services.
3. Fees of \$4,000 or less are payable in full in advance of work, fees over \$4,000 require a 50% down payment and a mutually agreed upon payment reschedule (customarily, immediately prior to the release of the final product from Rehab My Rehab, LLC).
4. Customary expenses (copying, overnight delivery, etc.) are billable at cost + 15%.
5. Ask about "Not to Exceed" Agreements for projects > \$10,000.
